

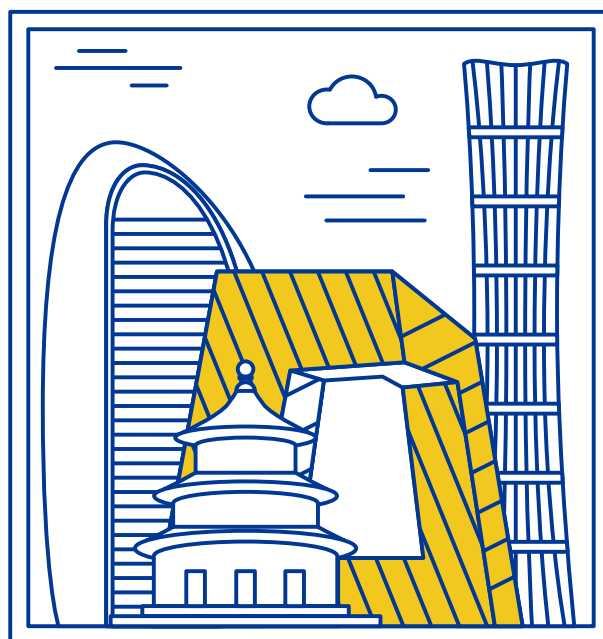

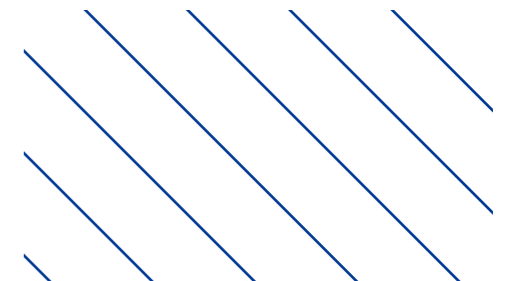

Message from the Chairman



In 2022, the global situation changed dramatically. Faced with the economic downturn, shrinking demands, intensified industrial competition as well as the digital technology revolution with the rise of digital economy, there is a growing national and social demand for cyber security. As a leading cyber security company in China, Qi An Xin has risen to the challenge and achieved three major victories in the complex market environment, including turning losses into profits, establishing a "Zero Incidence" record and implementing a successful corporate reform. We have thus reached a new level of high-quality development.

Our outstanding achievements are attributable to our sustainable development philosophy and actions such as clear vision of the industry, continuous pursuit of product value, strict adherence to safe operations as well as the protection of employee welfare. In 2022, we maintained close communication with our stakeholders to sort out and identify 22 ESG issues that need to be prioritized by Qi An Xin. Based on these issues, we have been working on identifying ESG risks and strengthening ESG management with information disclosure in each branch/subsidiary of the Group to effectively promote corporate sustainable development.

As a pioneer in cyber security industry, we have always believed that cyber security is not only necessary for the Company, but also for the country and the people. In 2022, under the direction of the national policy, we supported the digital economy of China and the world by continuously strengthening our innovative R&D capacity and improving our service standards. In 2022, we invested RMB 1.694 billion in R&D and acquired 164 invention patents, 14 design patents and 131 software copyrights. In addition, we achieved "Zero Incidence" in the Winter Olympics and hence have been included in the *Outstanding Case Studies: The 20th Anniversary of the National Standard for Cybersecurity*.

In order to further promote the development of the industry and cultivate high-quality talents, Qi An Xin has made continuous efforts to the training of cyber security talents, university-enterprise cooperation, industry competitions, and knowledge exchanges, so as to build the ecology of the cyber security industry chain together. We have established Tiger Tally base in Mianyang, Wuhan and Qingdao and etc., and have nurtured more than 3,600 cyber security talents in various key areas such as finance, transportation and energy. We cooperate with numerous universities to promote the integration of industry, academia and research. We have also held national competitions such as DataCon to encourage industry innovations and cooperation. Additionally, we developed a diverse certification system, providing a paradigm cyber security talent training. Last but not the least, we produced more than twenty industry open-source reports which represent years of Qi An Xin's industry insights.

We attach great importance to the rights and interests of our employees and their career development. Therefore, we have established a long-term mechanism for employee care, which promotes self-renewal and self-improvement while enhancing the sense of belonging and happiness of our employees. Adhering to the principle of equal employment, we built a fair and reasonable reward system along with the expansion of democratic communication and feedback channels to create a harmonious and stable working environment. At the same time, we have also set up dual channels for career development and optimized the "Sword Casting", "Flag Bearing" and "Setting Sail" Programs to build a diverse talent training system. 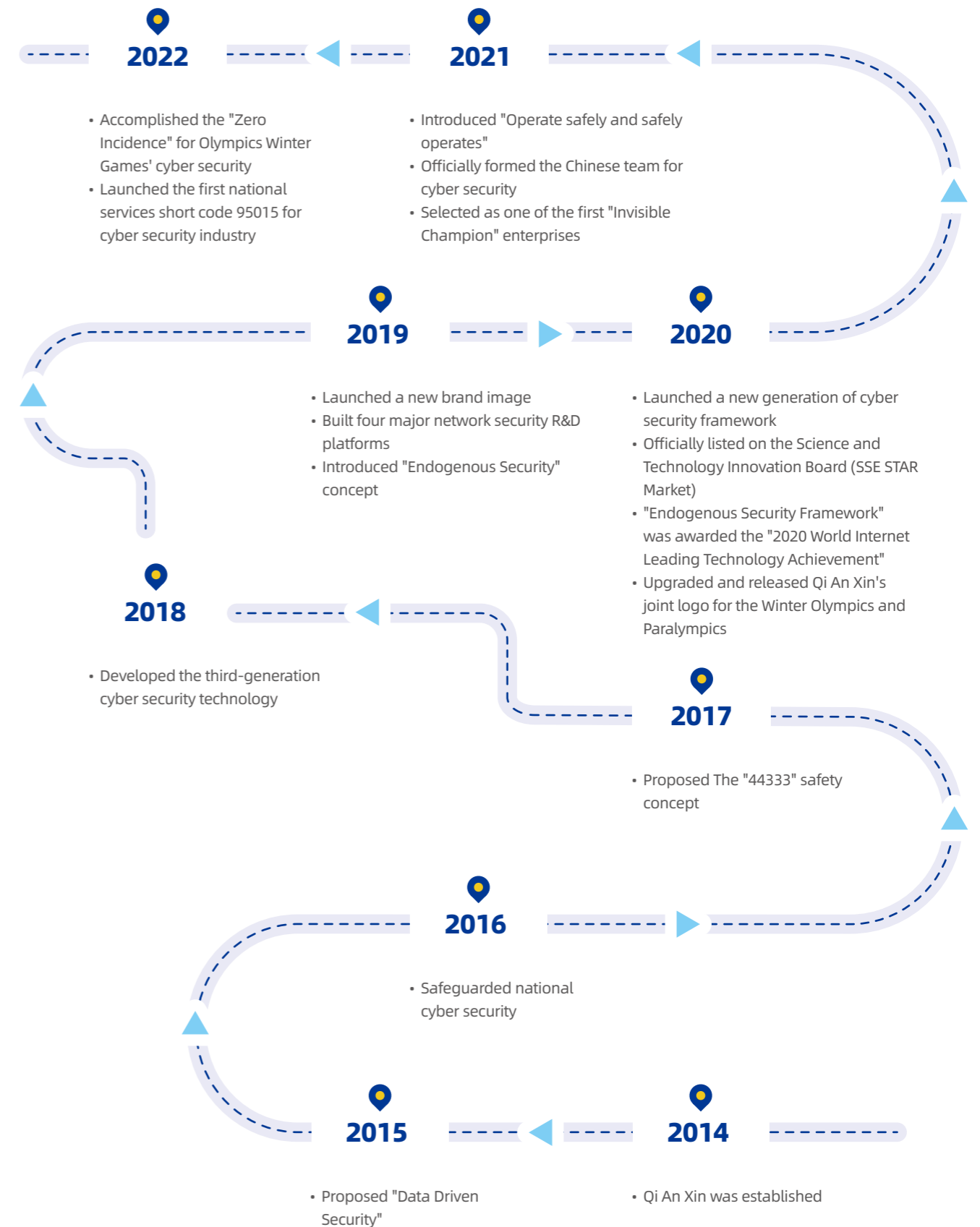

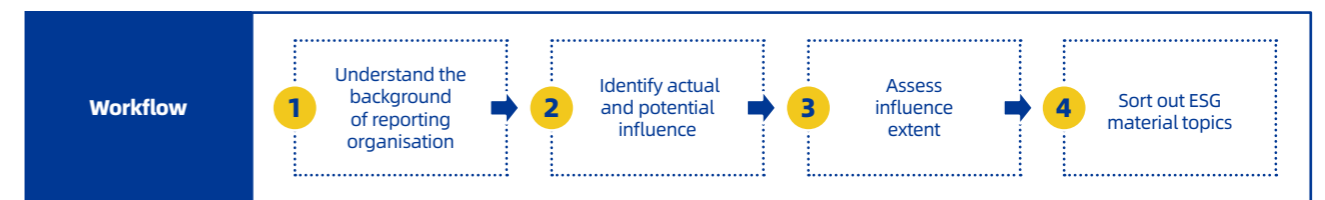
ESG Materiality Analysis



To identify major environmental, social and governance topics scientifically and precisely, Qi An Xin has conducted a substantive analysis of material topics with reference to the guide of determining the material topic matrix as stated in *GRI Standards (Version 2021)*.

To analyze material topics better, Qi An Xin has followed domestic and international policies, referred to domestic and foreign disclosure standards and guides, learned from its peers, and sought advice from experts and stakeholders. Through questionnaire surveys and interviews, we have communicated with stakeholders about their expectations of our sustainable development.

Through the "Medical Assistance Program", "Rural Development Program", and "Educational Assistance Program", we have reduced their risk of slipping back into poverty due to illness, labor weakening, education, etc. As of the end of 2022, the total amount of funds donated by Qi An Xin to poverty alleviation exceeded RMB 46.43 million.

This also helps to reduce the chances of struggling families returning to poverty due to poor health and diseases as well as improve the health and wellbeing of residents, contributing to Healthy China initiative. In the office, we have installed and maintained water conservation facilities, and introduced the efficient wastewater and garbage sorting system to minimize pollution to water resources.

[Feature Story 1] Shouldering the National Mission and Safeguarding the National Cyber Security

As a new leader in cyber security products and services, Qi An Xin has doubled its efforts to enhance its defensive abilities against cyber security attacks, threat identification, situational awareness and emergency response. Taking on the mission of "safeguarding national cyber security", Qi An Xin aspires to create a safe cyberspace and provide strong cyber security support for major national events.

In 2022, Qi An Xin achieved "Zero Incidence" throughout the Winter Olympic Games and ensured the stable operation of the 20th National Congress of the CPC, among many other achievements. On that basis, Qi An Xin has also undertaken many security tasks for important national events, including but not limited to ensuring the smooth running of major international conferences such as the "Belt and Road" International Cooperation Summit Forum, the World Expo and the Asian Civilization Dialogue Conference. The Company has also provided cyber security services for the 70th National Day and the deployment of cyber security equipment for the China Academic Conference on Digital Economy Development and Governance. With exceptional capabilities and practical actions, Qi An Xin safeguards national cybersecurity and duly fulfills the responsibilities of a cybersecurity guardian.

※ **Safeguarding cyber security for Beijing Olympic and Paralympic Winter Games**

As the official cyber security service and antivirus sponsor of the 2022 Beijing Winter Olympic and Paralympic Games, Qi An Xin has been upholding the concept of "making the Winter Olympics safer and the world a better place". With the purpose of serving the Winter Olympics and ensuring the infrastructure security of critical information, Qi An Xin honored its commitment to "complete, comprehensive, and end-to-end" responsibility of safeguarding cyber security in major events with its professional advantages.



Qi An Xin focused its efforts on personnel mobilization, organizational guarantee, on-site duty and routine inspection to guarantee cyber security for the Beijing Olympic and Paralympic Winter Games. After undertaking the national key R&D program of the Ministry of Science and Technology titled "Research and Application of Key Technology on Security Detection and Safeguarding of Network and Systems under Continuous Operation During the Winter Olympic and Paralympic Games", we developed third-generation cyber security technology, and achieved technical breakthroughs in key areas such as artificial intelligence security analysis engine, situational awareness, threat intelligence, supply chain security detection, and accurate attack analysis. Our efforts broke the monopoly of cyber security service by foreign cyber technology companies and settled all kinds of domestic and international network attacks effectively during the event.

In March 2022, Qi An Xin accomplished the cyber security safeguarding task for Beijing Olympic and Paralympic Winter Games successfully, with "Zero Incidence" following domestic regulations, and relying on domestic products, technologies, and services. It was an exemplary and a constructive experience for national critical information infrastructure and cyber security safeguarding of major events.

※ **Safeguarding cyber security for the 20th National Congress of the CPC**

To guarantee the stable and safe operation of network systems for over 300 institutions amid the 20th National Congress of the CPC, Qi An Xin implemented security tasks and safeguarding measures following the principles of "inspection, rectification, monitoring, analysis, response and verification". To this end, the Company allocated over 1,000 front-line experts and 500 back-end security analysis engineers, and more than 5,000 SkyEye, TianQing, NGSOC and other cyber security products. Moreover, Qi An Xin arranged emergency response teams in some key areas to safeguard cyber security for the success of the 20th National Congress of the CPC.

Qi An Xin put functions into service timely and kept systems running stably with no major faults amid the event through closed-loop business data, visual command, daily iterations and round-the-clock vigilance for the 20th National Congress of the CPC. The Company provided a combat-oriented and practical solution that can be replicated.



[Feature Story 2] Fostering a Healthy Ecology and Leading the Industry Development

Facing the rapid development of global economy and the approaching digital era, cyber security is an important topic of extensive concern, and an increasing number of enterprises have higher requirements of cyber security. As a cyber security expert, Qi An Xin stays committed to delivering high-quality cyber security services and products to customers, cultivating cyber security talents, and facilitating industry exchanges for better industry development.

We firmly believe that cyber security depends on professionals in the future. Adhering to the principle of "close cooperation among enterprises, universities and research institutions", the Company has focused its efforts on teaching, scientific research, competition internship, employment, and certification in higher education institutions. Through university-enterprise cooperation, funding in innovation, practice courses, and various competitions, the Company actively supports the cyber security major development in universities and contributes to training cyber security talents meeting market needs. At present, Qi An Xin has built ties with over 200 universities. It has established 10 joint laboratories together with major national universities and set up 40 cyber security courses to support cyber security talent cultivation technically as a responsible enterprise.



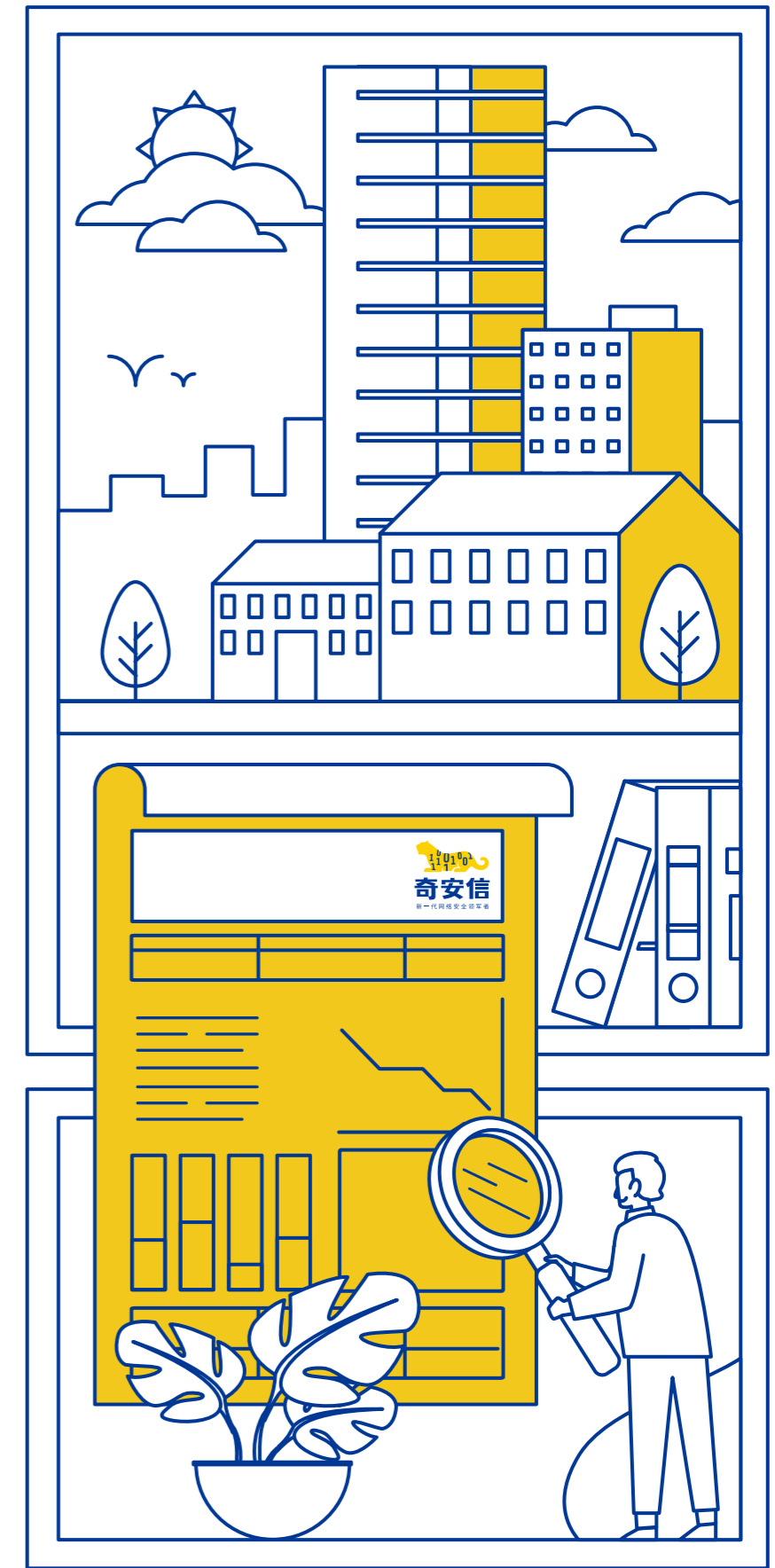
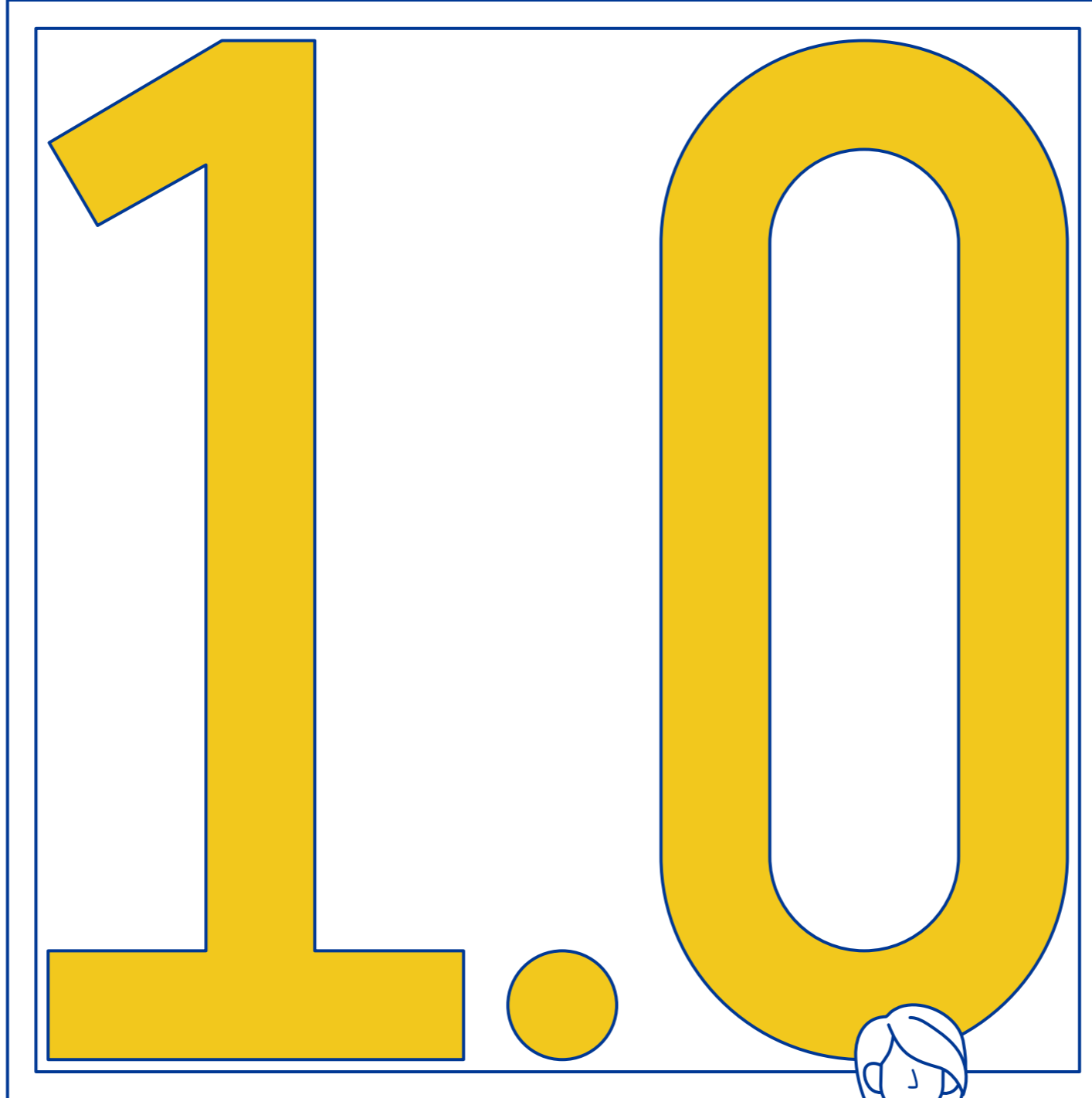
A favorable environment for coordinated development in the industry will promote cooperation and mutual benefits among partners. For this purpose, Qi An Xin actively participated in industry networking, discussing industry hot topics with industry experts and company representatives and sharing corporate experiences and insights. Qi An Xin was invited to attend 12 industry

networking events and the Company provided 20 hardware and software training activities for suppliers. Serving as white hat hackers and cyber security service providers for state-owned enterprises, Qi An Xin pools innovation and creation strengths in the industry chain to drive the healthy development of the industry. Paying close attention to the development situation of the industry, the Company stays updated on the latest information and development tendencies of the industry through profound surveys and analysis. In 2022, Qi An Xin published 26 industry insights as a practical reference for partners in the value chain to make cyber security decisions.



In addition, Qi An Xin is involved in the formulation of industrial standards to achieve constant breakthroughs in industry innovation and standard implementation, thus enabling high-quality industrial development. In 2022, Qi An Xin was involved in the preparation and revision of 30 industrial standards on information security. Furthermore, the Company was granted the Second Prize of 2022 China Standard Innovation Contribution Award for its contribution to industry standardization.

In the future, with the mission of "Make the cyberspace safer and make the world a better place", Qi An Xin will continue to design courses with more specific application scenarios, establish an education support system and improve its certification system to facilitate coordinated development in the industry while providing customers with better cyber security services.

Improving the Governance System and Operating in a Compliant and Stable Way

Qi An Xin takes effective corporate governance as its development cornerstone. Guiding corporate governance through party building, the Company has established and improved its corporate governance framework and compliance regulations, reinforced efforts to internal risk control, anti-corruption and anti-unfair competition, and enhanced its competence in information security and privacy protection for the purpose of stable operation complying laws and regulations.

In addition, Qi An Xin duly performs its information disclosure obligation as a listed company and communicates with investors and other important stakeholders fully to advance its governance compliance.



Governance Mechanism



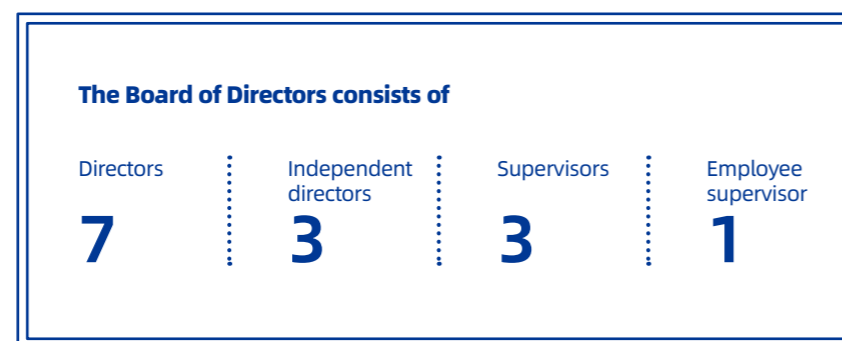
Qi An Xin has set up a robust corporate governance system enabling a transparent decision-making process and effective information disclosure, which enhances overall transparency and reliability, boosts investor confidence, and facilitates sustainable development in the long run.

In accordance with applicable laws and regulations, such as the *Company Law of the People's Republic of China*, the *Law of the People's Republic of China on Securities*, and the *Administrative Measures on Information Disclosure by Listed Companies*, the Company has set up the General Meeting of Shareholders, the Board of Directors, and the Board of Supervisors. The Board of Directors consists of three committees, namely, the Strategy Committee, the Audit Committee and the Nomination and Remuneration Committee, which work to propose suggestions and offer consultation to the Board of Directors in decision-making. The Board of Directors consists of 7 directors, including 3 independent directors, 3 supervisors, and 1 employee supervisor. The company's personnel structure is set up to effectively improve the internal governance framework and enhance the quality of internal governance.

The Company has also established internal governance regulations and rules covering all links of corporate governance, such as the Qi An Xin Articles of Association, the Rules of Procedure for the General Meeting of Shareholders, the Regulations on Independent Directors, the Management Measures for Related Party Transactions, and the Regulations on the Internal Reporting of Important Information, in order to ensure operation compliance for corporate governance and protect the legitimate rights and interests of stakeholders.

Qi An Xin places a strong emphasis on effective communication between the Board of Directors, the Board of Supervisors and senior executives to ensure sufficient discussion and review of decision-making and implementation. On the one hand, the Company has established multiple communication mechanisms, such as regular meetings, work reports, and information sharing, for better internal communication and cooperation in order to ensure the effective operation of the corporate governance mechanism. On the other hand, we have appointed an employee supervisor. It is a move to encourage employees to involve in corporate governance and management by giving extensive feedback and suggestions on sustainable development.

In 2022, the Board of Directors held 9 meetings, and the Board of Supervisors conducted 8 meetings.



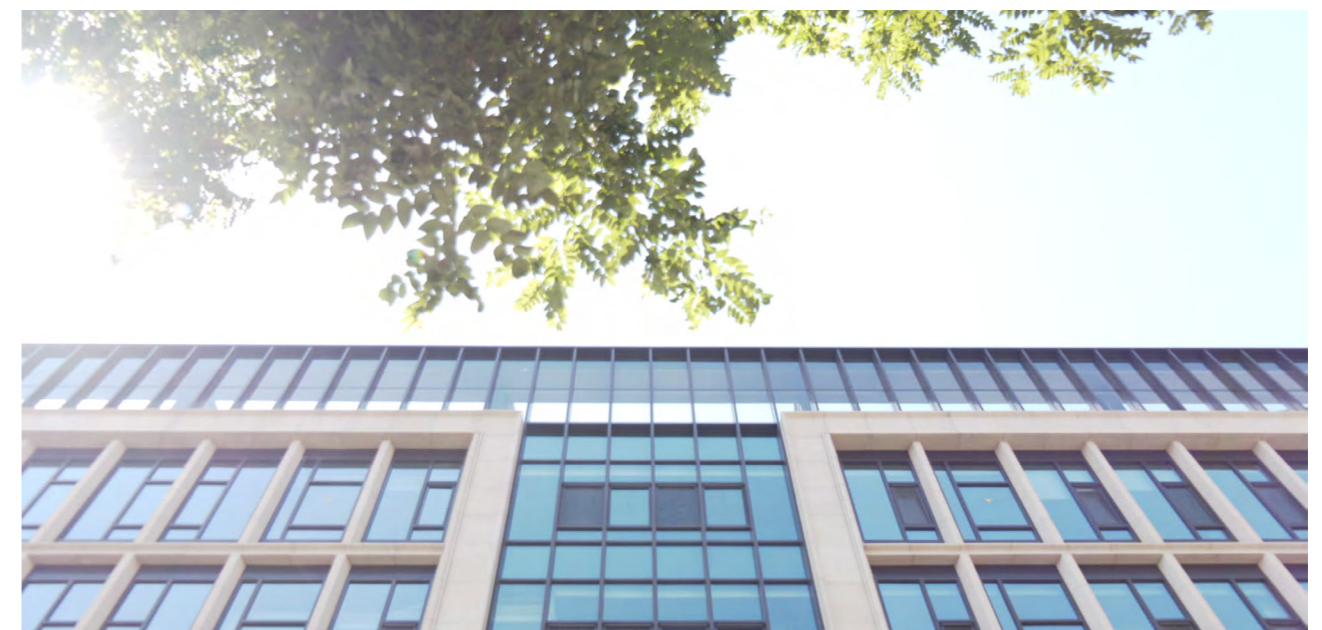
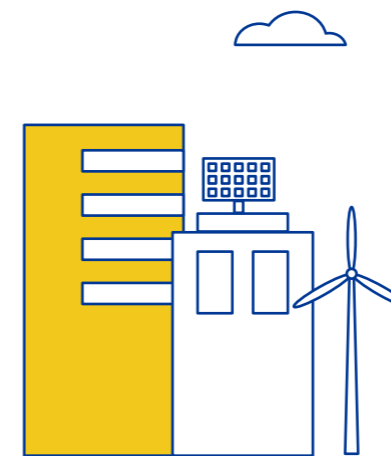
Investor Rights



Attaching great importance to investor relation management and investors' rights and interests protection, Qi An Xin strives to disclose true, accurate and complete information timely and fairly in accordance with the applicable laws and regulations, as well as the rules and requirements of the Company. To this end, the Company has established investor relationship management and information disclosure regulations, such as the *Management Regulations on Investor Relations*, and the *Management Regulations on Information Disclosure*. In line with these regulations, we strengthen communication and interaction with investors, and reply to their concerns timely in order to protect the legal rights and interests of investors.

To give all investors equal access to corporate information, we disclose detailed information on performance, development strategy, and risk management via the designated website and other information disclosure media channels specified by the China Securities Regulatory Commission per regular and interim reporting procedures to give investors a full picture of our operational situation and future planning. Furthermore, the Company responds to issues raised by investors via such channels as the investor hotline and the investor interaction platform.

Qi An Xin communicates with its investors regularly through multiple channels. In 2022, the Company organized an online annual performance presentation to interact with investors. The Company also provides a regular briefing on its current operational situation for investors. In 2022, the Company organized 8 surveys among over 100 investors, and answered questions raised by investors at the E-interaction Platform of the Shanghai Stock Exchange for 97 times, thus, building close ties with investors.



Compliance with Laws and Regulations



It is a basic requirement for an enterprise to comply with laws and regulations. Doing so helps guard against risks and facilitate industry development. Qi An Xin abides by strict business ethics and corporate governance requirements and complies with provisions on corporate governance as specified in the *Rules Governing the Listing of Stocks on the Sci-tech Innovation Board* to ensure equal, fair and open decision-making. In line with these requirements and provisions, the Company continues to step up compliance risk management.

Operation Compliance

Qi An Xin attaches great importance to operation compliance. In 2022, we established an operation and management compliance system focusing on multiple key areas for compliance and worked out operation compliance procedures and regulations accordingly in accordance with the *Three-year Plan of the Operation and Management Compliance System*. Furthermore, the Company continuously optimizes the organizational system, the institutional system, the operation mechanism and safeguard measures while giving full play to the "three defense lines" in order to foster better operation compliance.

Also, the Company has formulated internal control regulations and internal audit management regulations for business and functional departments. The audit department comprises financial, business auditors and IT auditors who are responsible for audits in accordance with audit requirements to supervise design and implementation effectiveness of key business areas and processes. As of December 2022, the Company audited 20 items per the audit plan and followed up on rectification. The rectification rate in 2022 achieved 92.28%.

Risk Management

In order to enhance risk management competence, Qi An Xin organizes annual risk identification and assessment regularly in line with the *Regulations on Overall Risk Management*. According to annual operation plans, the Company mandates business and functional departments as well as subsidiaries to identify their own risks, work out response plans, and prepare the *Annual List of Major Risks*. At the same time, the Company has established a quarterly monitoring and reporting mechanism for major risks. To be specific, we follow up and assess the implementation of response plans for major risks quarterly through sampling, on-site inspection and data analysis, to ensure the effective implementation of the response plan for major risks and report the implementation of prevention and control of major risks to management.

Anti-corruption and Business Ethics

Adhering to the principle of integrity, Qi An Xin makes constant efforts to foster a clean operation environment, and combat corruption in any form.

Qi An Xin has formulated a series of internal regulations to regulate anti-corruption, including the *Anti-fraud Management Rules*, the *Management Rules for Conflict of Interest*, the *Management Rules for Commercial Operations and Ethics*, and the *Employee Manual*. We have established anti-corruption and compliance supervision department under reform and development department to fulfill the duty of anti-corruption and compliance supervision while constructing an effective anti-corruption institutional system. In addition, Qi An Xin strengthens anti-fraud responsibility management among suppliers by formulating internal management regulations, such as the *Supplier Management Regulations*, and the *Management Rules for Commercial Operations and Ethics*.

※ Stepping up discipline supervision and building a clean management team

In order to establish an upright management team and create a non-corrupt workplace, Qi An Xin has formulated strict implementations of evaluation regulations, specifying integrity assessment for promotions and rewards. The competent departments team up to regulate discipline supervision and review procedures. In 2022, 452 employees had undergone evaluation for promotion or award.

※ Providing smooth corruption whistleblowing channels

Qi An Xin has provided employees with multiple whistleblowing channels and distributed the *Notice on Strengthening Whistle-blower Protection and Award*, clarifying whistleblowing rules. The Company has defined the whistle-blower definition, protection and award, as well as whistleblowing scope, channels and requirements clearly. To support anti-corruption, employees are allowed to report acts of corruption and other misconducts violating discipline and regulations via multiple reasonable communication channels, such as the Lanxin platform, phone calls, emails, WeChat account, letters, and visits upon appointment. Whistleblowers will receive protection, cash award or reward in other forms.

Qi An Xin accepts all corruption reports, launches corruption investigations, and releases investigation results for all cases. In the future, the Company will double its efforts to crack down on corruption to ensure the integrity of the Company's operations.

※ Introducing new anti-corruption education

Qi An Xin attaches importance to integrity education by introducing new anti-corruption education modes. On the one side, the Company has established the Lanxin static display platform to release documents and images of anti-corruption and integrity, encouraging clean practices. On the other side, the Company has pushed supervision notices to all employees via the Lanxin Wechat official account, and the supervision email, in order to warn employees against corruption. In 2022, Qi An Xin disseminated 2 "Supervision Notices" to all employees and 4 "Supervision Notices" to relevant departments via the email, the integrity official account and the "Complaint and Whistleblowing" segment of the Lanxin platform.

Guiding Corporate Governance through Party Building



In 2022 when the 20th National Congress of the CPC was held while the "14th Five-year Plan" was in progress, the Qi An Xin Party Committee, under the guidance of Xi Jinping's Thought on Socialism with Chinese Characteristics for a New Era, followed the general requirements for strengthening the Party, and the Party's organizational line in the new era, learned the guiding principles of the 19th National Congress of the CPC, the 20th National Congress of the CPC. It also attended all plenary sessions of the 19th Party Central Committee and implemented the deployment requirements of boosting China's strength in aerospace as specified in the 20th National Congress of the CPC and the 13th Beijing CPC Congress. 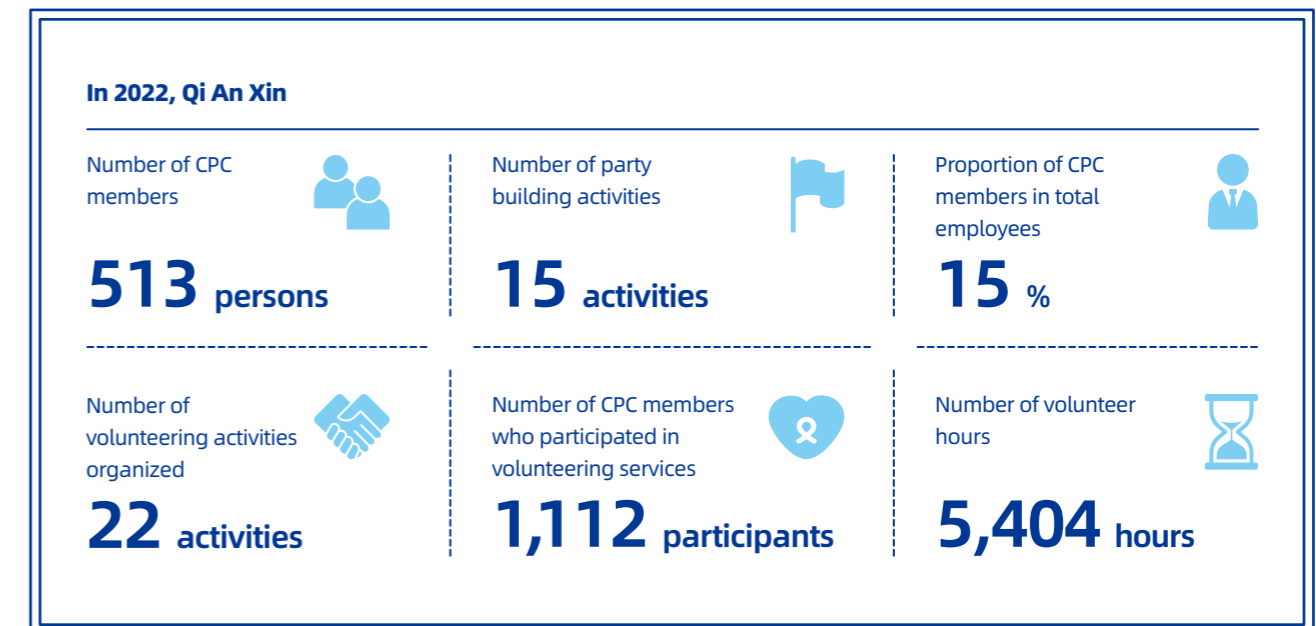


Laying Solid Foundation for Organizational Building

The Party Committee of Qi An Xin effectively strengthens organizational building by strictly abiding by Party organization regulations. Its party branches actively participate in the "Three Meetings and One Lecture system" and other party organization activities, standardizes the management and development of party members. In line with applicable regulations, the Party Committee facilitates the collection, use, examination, approval and management of monthly party membership dues, which are collected in full. In 2022, all CPC members paid party membership dues in full amount. The Party Committee of Qi An Xin conducts overall arrangements of party membership dues for its specified purpose only, keeping income within expenses. The Party Committee continues to improve standard-based management of party branches so that party organizations give full play to their guiding role.

In 2022, the Party Committee of Qi An Xin comprised 513 CPC members, and organized 15 party building activities. The Party Committee admitted 4 new CPC members, including 1 senior executive and 3 key employees, while 26 probationary CPC members were converted to permanent.

In addition, the Party Committee actively engaged in 22 volunteering activities, including community services and technical support, with a total of 1,112 participants in these activities and a total of 5,404 hours of volunteer service. As such, CPC members played an exemplary and vanguard role, and primary-level party organizations played a key role.



Nurturing the Root and Soul with Ideals and Faith

The Party Committee of Qi An Xin adheres to political guidance, strengthens theoretical study, and enhances party consciousness. Staying true to the mission, and moving ahead bravely

In August 2022, the Party Committee of Qi An Xin held a conference themed "Staying True to the Mission, and Moving Ahead Bravely". During the conference, Zhang Chongbin, a delegate to the 13th Beijing CPC Congress and Vice President of the Group, delivered a keynote speech. Over 100 CPC members from 17 party branches nationwide attended the conference in person or online. They have remained committed to staying true to the Party's original aspiration and the founding mission, and acting on the beliefs, so as to unify their knowledge, faith and action.



Pooling Minds and Strengths through Party Building Brands

The Party Committee of Qi An Xin has spared no efforts to create the party-building brand of "Red Cloud Initiative", leading the integration of all work with party building. These party-building brands include the Red Cloud Exhibition Hall, Red Cloud Library, and the Online Volunteers at the online platform. Relying on what we have learned, we will strive to enhance the Party spirit, improve abilities, advance work, and promote development in order to better safeguard national cyber security.

In 2022, there were 237 Red Cloud Exhibitions Hall totally. Over 1,000 schools in Shandong Province organized students to visit these exhibitions. In July 2022, the Red Cloud Exhibition Hall was released in the Uygur language. In August 2022, the *Original Party's Aspiration and Party Spirit* was published officially. The reports over the Red Cloud Exhibition Hall were granted the Major Theme Report Prize in the 32nd China News Award.

The intelligent party-building system of Qi An Xin has multiple segments, such as party news, videos, learning materials, learning plans and knowledge contests. To be specific, the system covers 12 authoritative media websites, 980 party-building videos across 10 categories, with 10 issues updated per month, 23 episodes of the expert interview program, 2 sets of courses, with 4 issues updated per month, and 400 party history knowledge questions, including 89 topics concerning the the 20th National Congress of the CPC. The systems have received over 3,000 hits, which is a good platform for party organizations to play a basic and guiding role.

The "Qi An Xin Cloud Team" set up by the Party Committee of Qi An Xin has played a key role in safeguarding cyber security for major national events. At the Beijing Olympic and Paralympic Winter Games, the temporary party branch and the young cyber security guard team tasked their members with difficult jobs and tough technical tasks, honoring the commitment to zero cyber security incidents. During the 20th National Congress of the CPC, over 1,000 front-line teams with CPC members as the main force performed cyber security tasks with due diligence. In 2022, 120 CPC members were awarded the title of "Red Cloud Model" while 10 teams were awarded the title "Red Cloud Team".

Information Security and Privacy Protection



As a leading cyber security company, Qi An Xin attaches great importance to information security and privacy protection within the enterprise. The Company strictly complies with applicable laws and regulations, such as the *Cyber Security Law of the People's Republic of China*, the *Data Security Law of the People's Republic of China*, and the *Personal Information Protection Law of the People's Republic of China*, to protect information and data security.

Qi An Xin has set up the Data Security Governance Committee, with the Chairman of the Board as the director, and the President of the Group as the deputy director. Under the guidance of the Committee, the Company has set the data security strategy goal of "protecting data in accordance with laws and regulations, implementing full governance to develop into a leader in data security, refining digital security products to serve customers better, and conducting good practices with social value". As members of the Data Security Governance Committee, the Group's vice presidents ensure the implementation of data security policies in all aspects. Through the Data Security Governance Committee, the company effectively standardizes the authorization process within the Group to ensure the appropriate implementation of the allocation, use and recovery of permissions, ensure the safe, orderly and stable operation of each application, and reduce the risk of data abuse, misuse and leakage.

At the same time, in line with applicable laws and regulations, Qi An Xin has established a comprehensive information security and privacy protection system that includes automated processes, full protection and effective monitoring measures. Integrating the system into business operation, the Company charts information and data security plans while planning business as a move to implement the endogenous security belief advocated by the Company.

Qi An Xin has taken various measures to ensure information security and customer privacy. Based on legal regulations, usage scenarios and three major criteria of data confidentiality, importance and risk of leakage, the Company has made a detailed classification of data and managed the whole life cycle from six processes, namely, data collection, transmission, data storage, data use, data sharing and data recovery, to realize data security protection from the perspective of data processing security. The Company has also implemented data processing security measures such as appointing leaders responsible for data security, allocating personnel, organizing assessment, and responding to emergencies properly.

To guarantee safe operation, Qi An Xin has introduced a series of management measures covering incident prevention, audit during an incident, post-incident tracing, and actions specific to operational scenarios in order to regulate data security management. In 2022, the Company had no severe information leakage incidents.

We strengthen data security protection by enhancing the protection awareness of employees through training. In 2022, the data security and privacy protection training generated 10,970 participants. To be specific, the Company organized data security awareness training in terms of data security background, cases, prevention measures, and regulations, with the participation of a total of 4,577 employees. The Company has also implemented cyber security training in terms of basic knowledge and protection measures in routine work, and 6,000 employees received such trainings.

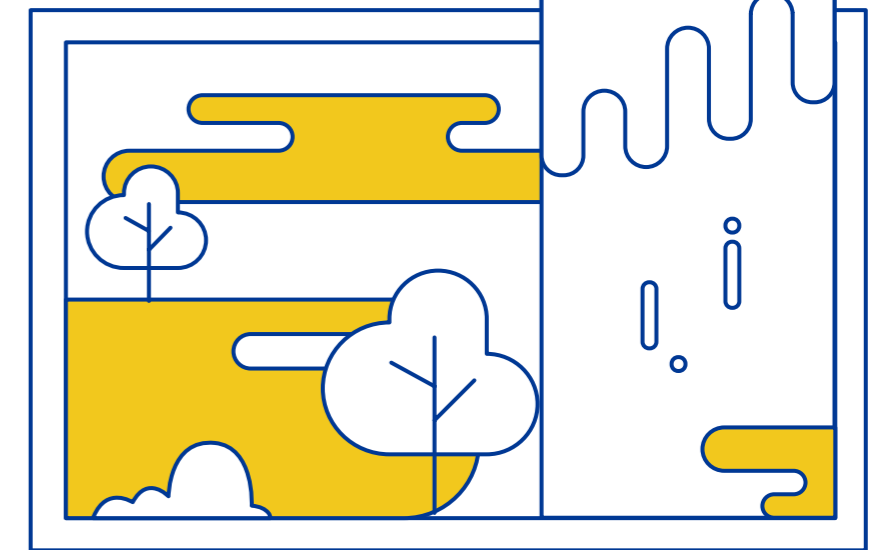
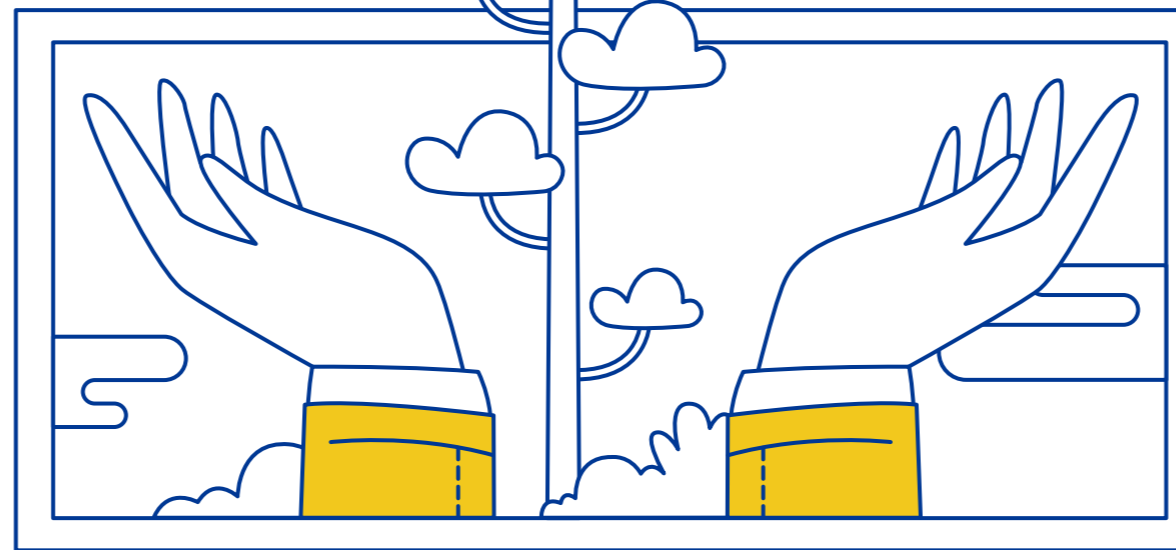
Training over the Management Rules for Personal Information Security

During the training, personal information security terms and their definitions were introduced in detail. 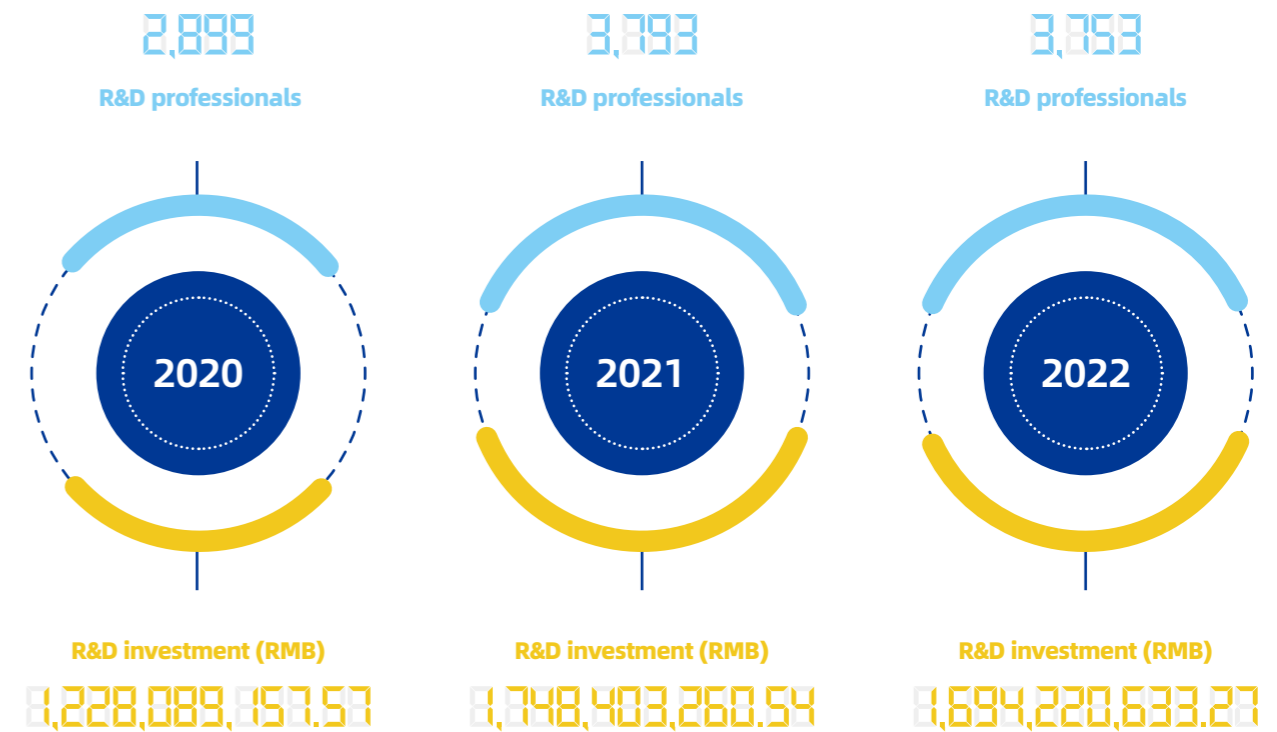
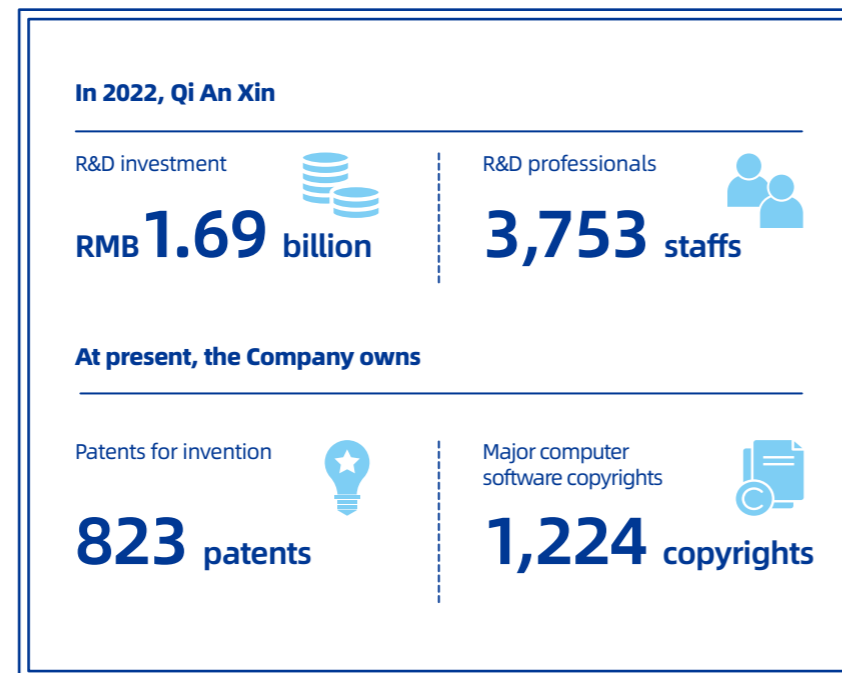
With the aim of creating social value, Qi An Xin continues to enhance its R&D strength, and consolidates its technical advantages to deliver premium and diverse products and services. We remain committed to empowering the digital development and security transformation of society and contributing to the high-quality and sustainable development of the state by designing efficient tools and establishing a comprehensive service system depending on scientific and technological innovation.

R&D and Innovation

As a leading supplier of cyber security products and services in China, Qi An Xin takes R&D and innovation strength as the foundation to survive and develop prosperously. In 2022, Qi An Xin doubled efforts to enhance R&D strength by increasing the investment in R&D professionals and funds, facilitating technological innovation and advancement through the R&D platform matrix, so as to maintain its leading competitive edge in the industry. At the same time, the Company attaches great importance to intellectual property protection to protect innovation from the root.

R&D Strength

To boost the organization's R&D vitality, Qi An Xin adheres to the development path of strengthening R&D and the platform-based R&D strategy using "Lego-ization" thinking. The Company has currently developed eight platforms, namely, "Sai Peng", "Noah", "Lei Er", "Zion", "Trantor", "Da Yu", "Xuan Ji" and "Gan Xing", and has over 30 platforms under research and development. Based on the cyber security R&D platform as the basic and core aspect, and a small number of customized modules, the Company is able to develop cyber security products and solutions quickly catering to the customized requirements of customers. Besides, the Company has set up its R&D centers in nine cities such as Chengdu, Jinan and Nanjing, laying a solid foundation for innovative network construction.



Intellectual Property Protection

Qi An Xin encourages invention and creation, and emphasizes the importance of protecting intellectual property. In accordance with the applicable laws and regulations, such as the *Trademark Law of the People's Republic of China*, the *Patent Law of the People's Republic of China*, and the *Copyright Law of the People's Republic of China*, the Company has formulated management regulations including the *Establishment of the Intellectual Property Management System*, the *Management Regulations on Intellectual Property*, and the *Management Regulations on Patents*.

To protect intellectual property better, Qi An Xin optimized intellectual property management in a targeted manner in 2022. Adhering to the basic principles of "application management" and "process management", Qi An Xin integrates intellectual property protection into the full product R&D process by engaging the intellectual property management team and the legal department throughout the process to guarantee timely and orderly intellectual property applications.

With "quality first" and "protection foremost" as supplementary principles, the Company erects intellectual property protection barriers and figures out more high-value patents through strict agency management, active mining and case grading. In addition, the Company identifies patents in the non-product systems (such as R&D system) regularly to protect intellectual property in underlying technology.

※ **Protecting the Company's Own Intellectual Property**

Qi An Xin has registered computer software copyrights for all its software products. To protect the products requiring independent branding, the Company conducted assessment and planning before eventually applying for trademarks and copyrights. For underlying technology or UI design, the Company will identify patentable technologies in R&D projects.

※ **Protecting the Intellectual Property of Third Parties**

Qi An Xin is engaged in joint R&D with third parties. For products and technologies under joint R&D, the Company makes efforts to protect intellectual property concerned pursuant to agreements, safeguard the signature rights of researchers, and clarify intellectual property application, ownership, exercise of rights, and earning distribution in cooperation contracts.

Systematic Top-notch Design

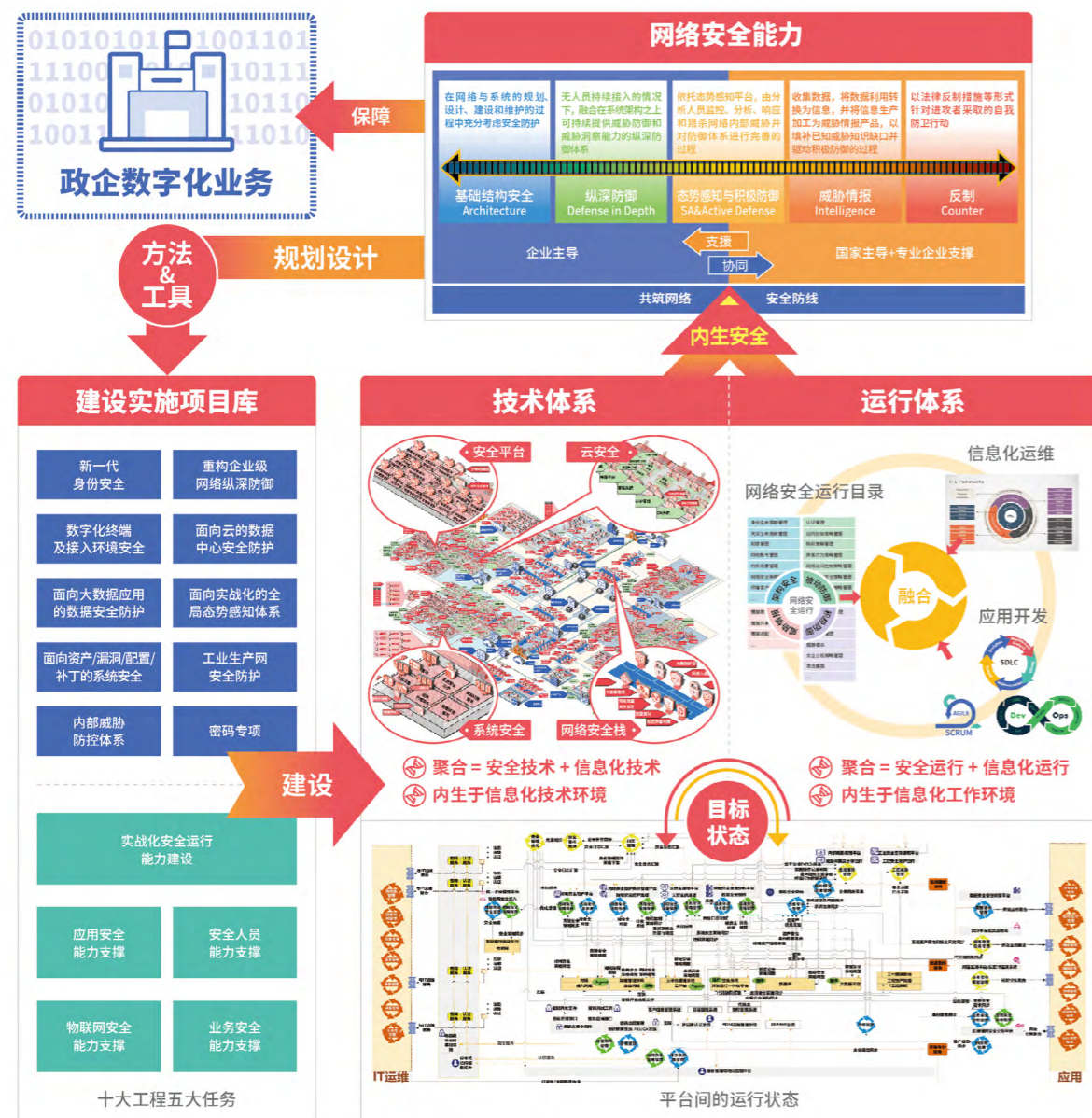

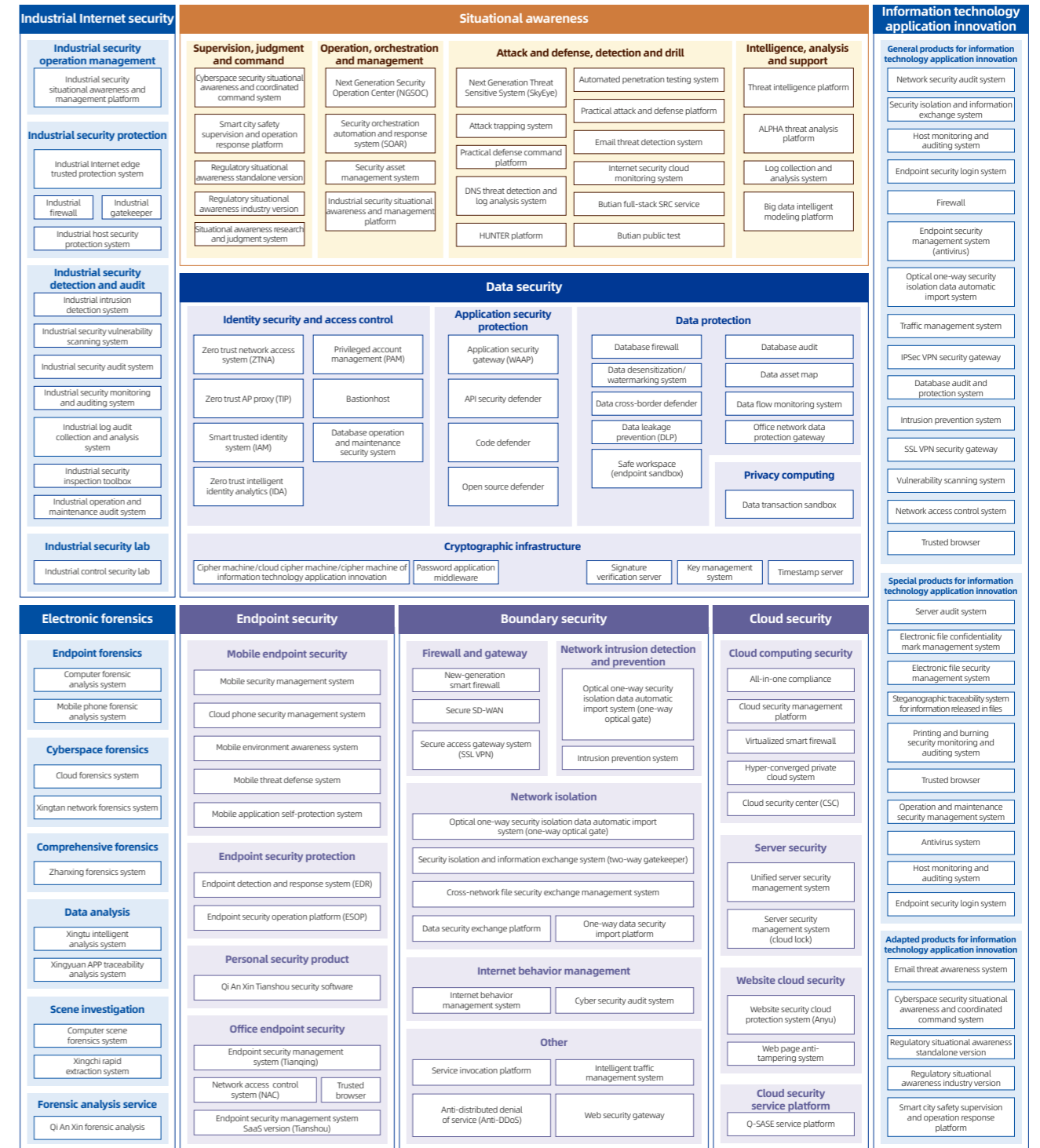

A new generation of enterprise cyber security framework (Endogenous Security Framework)

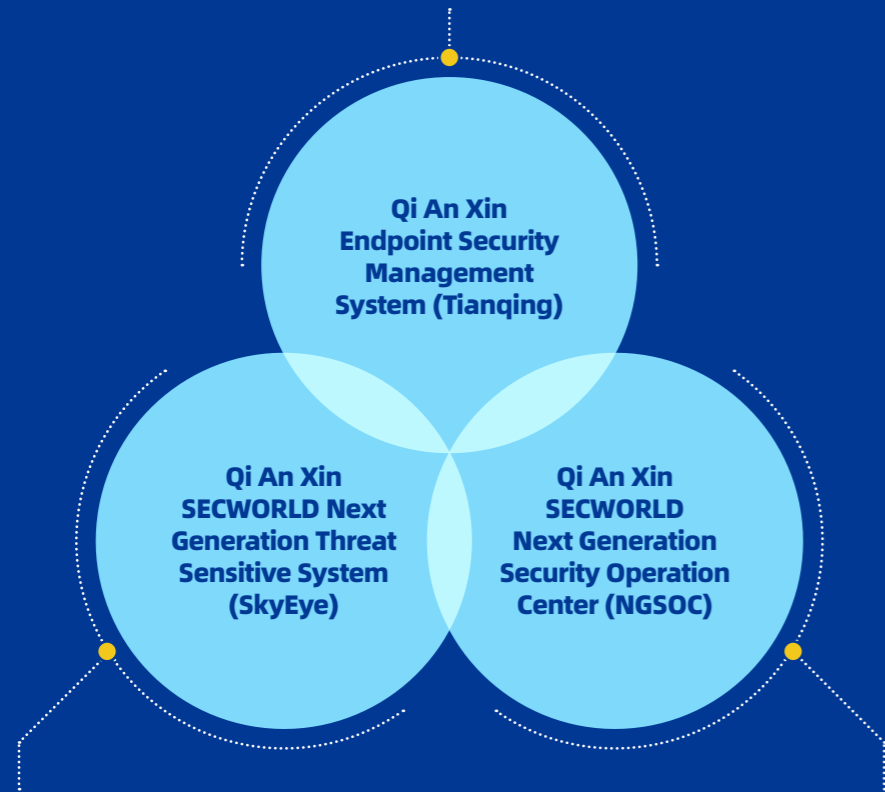
Systematic Security Products

Therefore, the Company is able to provide all-rounded cyber security protection solutions for customers.

Qi An Xin Tianqing Endpoint Security Management System, an integrated endpoint solution, is built based on the new generation of "Trantor" Endpoint Security Platform. With systematic defense and digital operation, the System helps governments and enterprises accurately identify, protect and monitor endpoints while enabling secure and reliable access to data and business at endpoints. The System is equipped with high-performance virus killing and vulnerability defense mechanisms as well as active defense engine, with the adoption of innovative technologies such as threat intelligence, big data analysis and security visualization. Thanks to these models and technologies, the System has multiple functions including compliance and reinforcement, threat defense and detection, operation and maintenance control and audit, endpoint data leakage prevention, and unified management and operation, which allow governments and enterprises to develop endpoint security capabilities that remain effective.



Specialized in attack and defense penetration and data analysis, Qi An Xin SECWORLD Next Generation Threat Sensitive System (SkyEye) provides customers with cyber security services and products focused on threat detection and response. Based on network traffic and endpoint EDR logs, SkyEye leverages threat intelligence, rule engine, file virtual execution, machine learning and other technologies to accurately detect the intrusion behaviors against hosts and servers in the network. Besides, the system enables storage and search of traffic logs and endpoints logs depending on the local big data platform. With threat intelligence and attack chain analysis, SkyEye works to analyze, investigate, backtrack events. Relying on boundary NDR, endpoint EDR, and automated orchestration, this product can block threats timely.

Building on the big data platform, and leveraging correlation analysis, machine learning and threat intelligence, Qi An Xin SECWORLD Next Generation Security Operation Center (NGSOC) helps governments and enterprises continuously monitor the security situation by collecting multiple and heterogeneous massive logs. Through upgrading from "passive defense" to "active defense", the System provides security administrators with decision-making support for risk assessment and emergency response, and also provides security operators with tools for threat detection, investigation, analysis and response. Currently, the platform has been put into practice for network protection by thousands of large governmental institutions and enterprises.

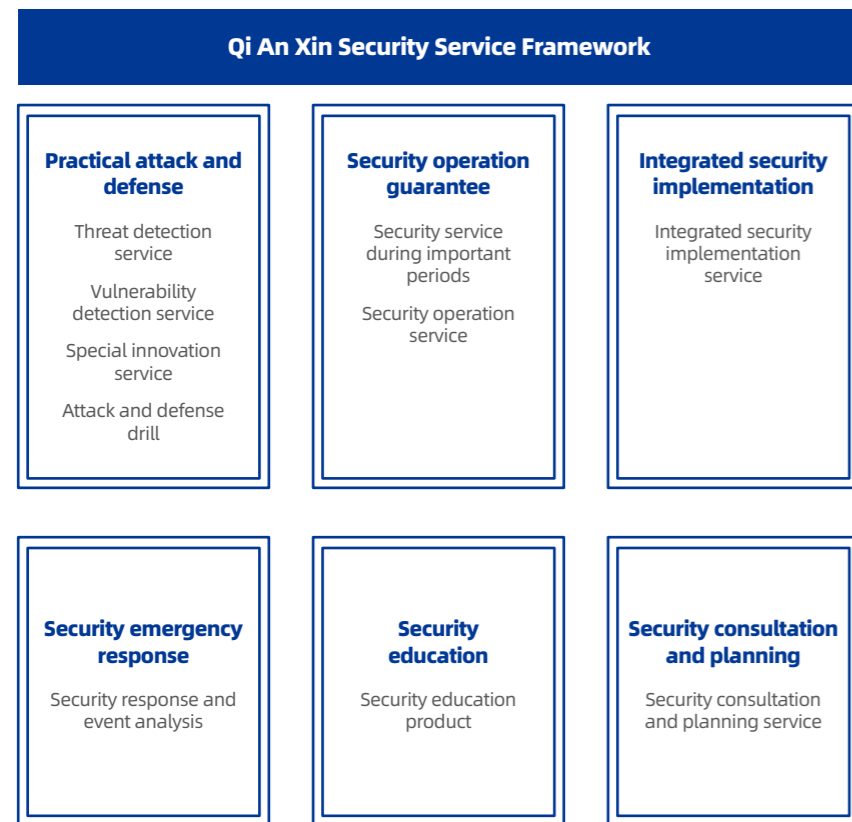


Practical Security Services

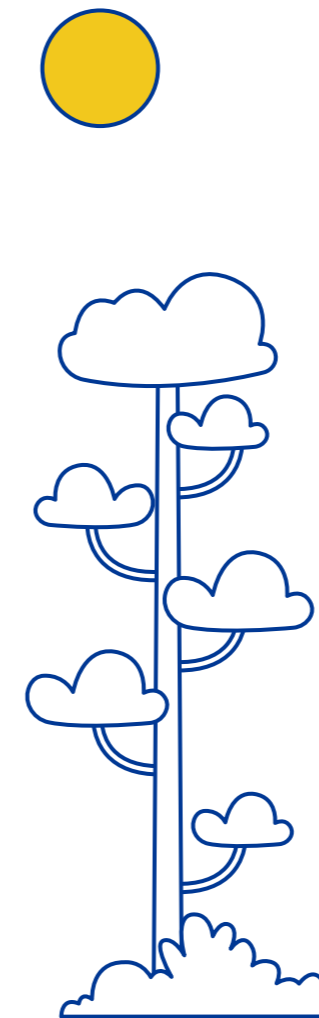
※ **Cyber security Safeguarding Service during Important Periods**

With 24/7 security monitoring, incident analysis and handling, and emergency response guarantee, Qi An Xin helps customers identify potential hazards fully, reinforce and rectify cyber security measures, and optimize cyber security strategies timely in order to enhance the cyber security safeguarding capabilities of important system operators during important periods.

In 2022, Qi An Xin undertook cyber security safeguarding tasks for major national events, such as the 20th National Congress of the CPC as well as the Beijing Winter Olympic and Paralympic Games, with its solid professional competence.

※ **Emergency Response Service**

To respond to customer needs, Qi An Xin has set up an offline cyber security emergency response service team that is one of its kind in the world. The team consists of over 2,000 engineers who possess emergency response competence, including 100 senior security experts and 300 experienced penetration testing engineers nationwide. ※ **Digital Management Tools**

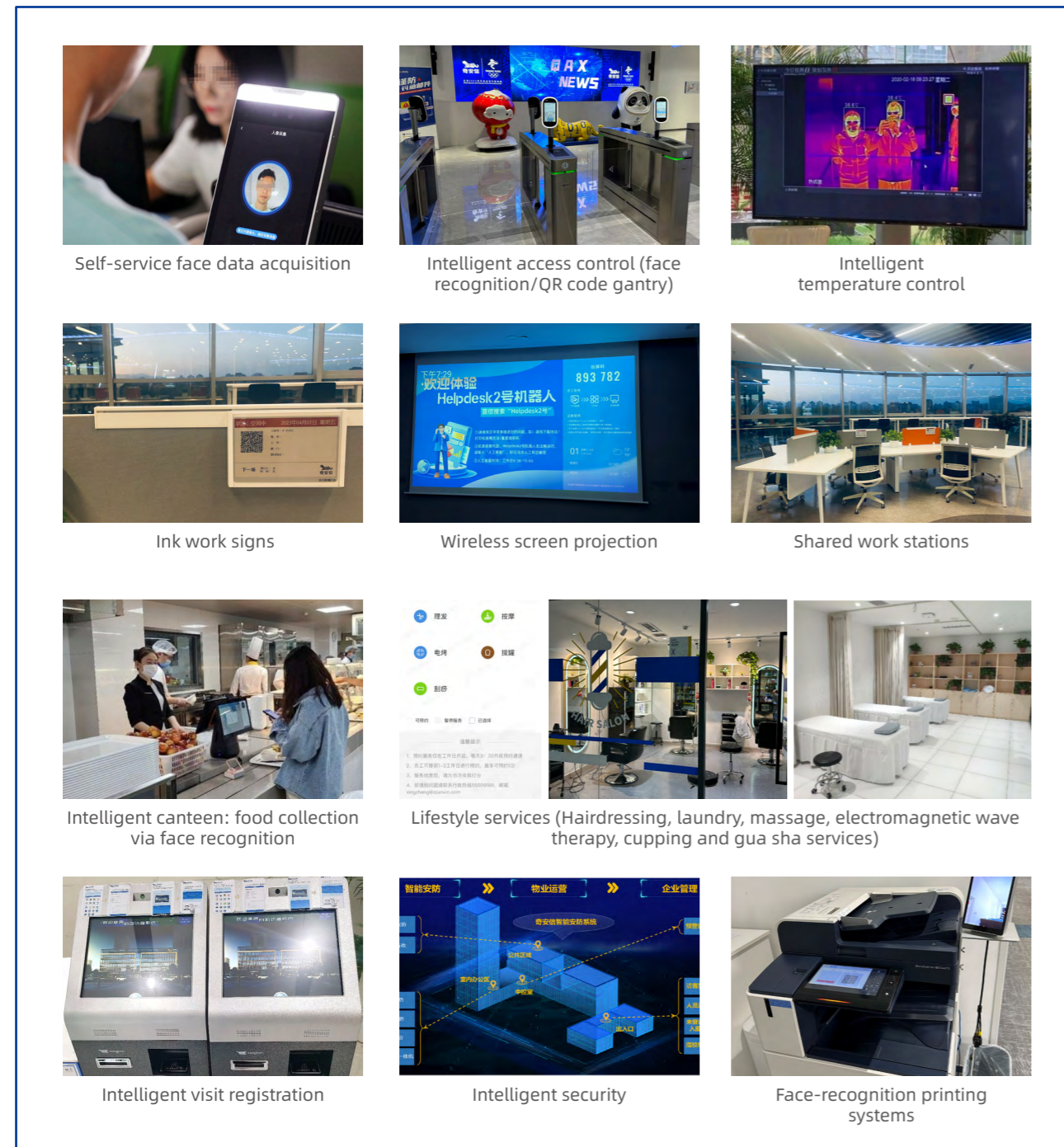

At the same time, it implements online management of all reimbursement business data to avoid tax risks. To meet the needs of the Company's rapid development, Qi An Xin has established an automated electronic signature system, allowing for accurate and standard-based business management.

※ Intelligent Building and Workplace Environment

Qi An Xin has now completed the preliminary construction of multi-dimensional "Intelligent+" digital scenarios for office, daily life and security. The unified security authentication is carried out through the QR code/face recognition function of Lanxin platform, a modular "Intelligent+" cloud platform. By relying on artificial intelligence, big data and cloud computing, it covers all business scenarios and breaks down barriers between devices and systems with intelligent capabilities.



※ Ensuring Safety in the Workplace

The "Intelligent+" cloud platform established by Qi An Xin ensures operational security and the safety of employees, data and property in the core areas in a reliable manner. Qi An Xin Security Center is equipped with an intelligent building security platform, which provides intelligent security through the combination of the intelligent security system and the regular monitoring system. Thanks to AI and big data, the intelligent building control system is able to carry out identity recognition and behavior control. These intelligent security facilities enable surveillance and early warning prior to incidents as well as investigations and forensics during incident and analysis and judgment after incidents, so as to safeguard environmental security.

The intelligent building control system functions to track visitors with abnormal behaviors, and analyze employees entering areas to which they have no access. In case of visitors with abnormal behaviors, the system will automatically identify potential targets with dangerous behaviors, target them according to faces and physical characteristics and analyze their space-time traces to remove external potential threats in the workplace. In case of employees entering the areas to which they have no access, the system will identify the identities of these employees by invocation of internal data, judge their behaviors with reference to preset security threat guidelines, give alarm through pop-up windows, voice warnings, map highlights, emails, and the app to inform persons in charge. This forms a quick and automated forensic process.

Establishing the Intelligent Data Platform with Intelligent Technology

The intelligent data platform covers general big data product capacity, digital operation management, and data security protection, providing a unified support platform for building internal efficient mechanisms and the digital development of business. The integration of security into operation meets the basic security needs in the industry, with the design of security products catering to the needs of society.



General Big Data Product Capacity

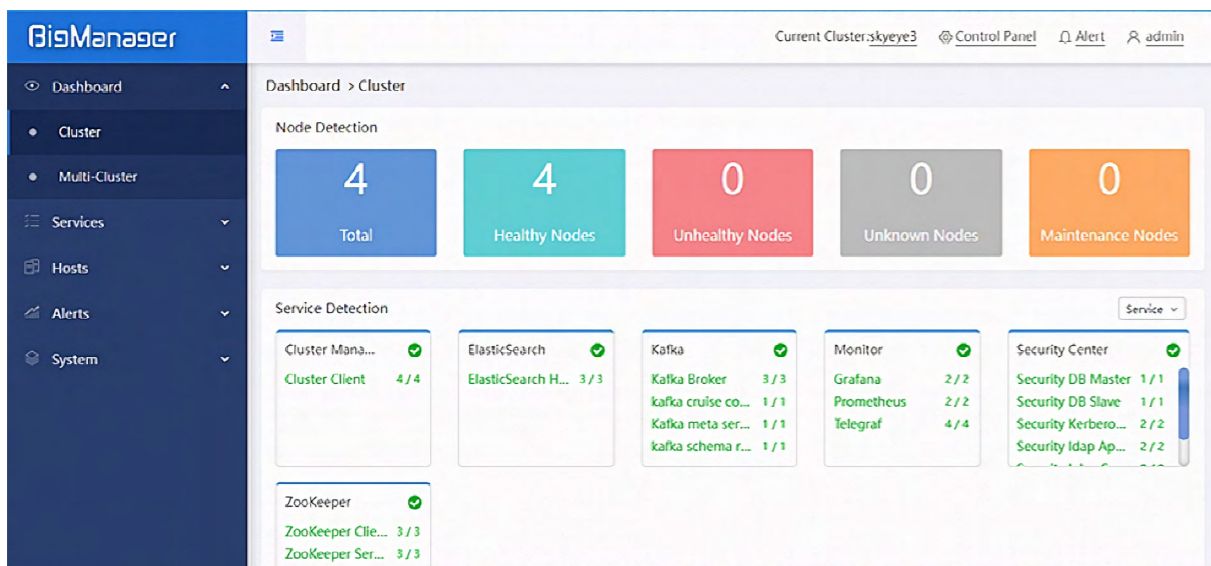

Through the Xuanji platform, the Company has established IPD, LTC, OTD and other business processes, and set up 210 data asset inventories and data sets in fields like human resource and finance, covering over 1,000 business indicators in all dimensions. The platform is also equipped with uniform indicators, technical metadata, and data exception alarms.

With industry-leading big data modular product capacity, Qi An Xin reduces technical difficulties and saves a large number of development resources when establishing intelligent data platforms.

The Company developed a digital customer service support system that allows users from various channels to report problems, record work orders, and facilitate problem resolution relying through digital indicators.

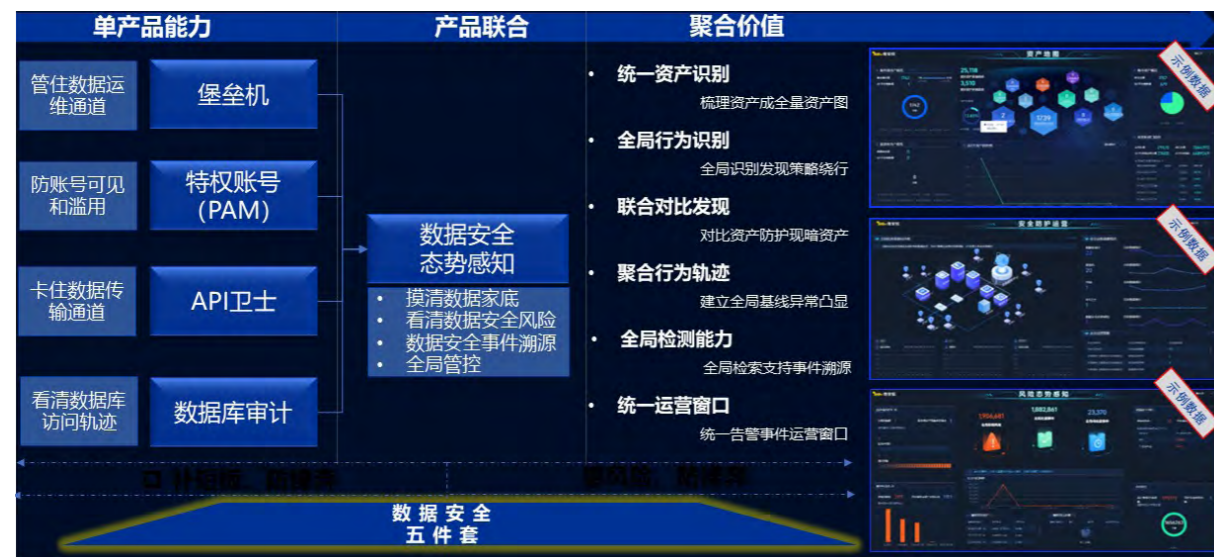


24/7 Operational Status Screen

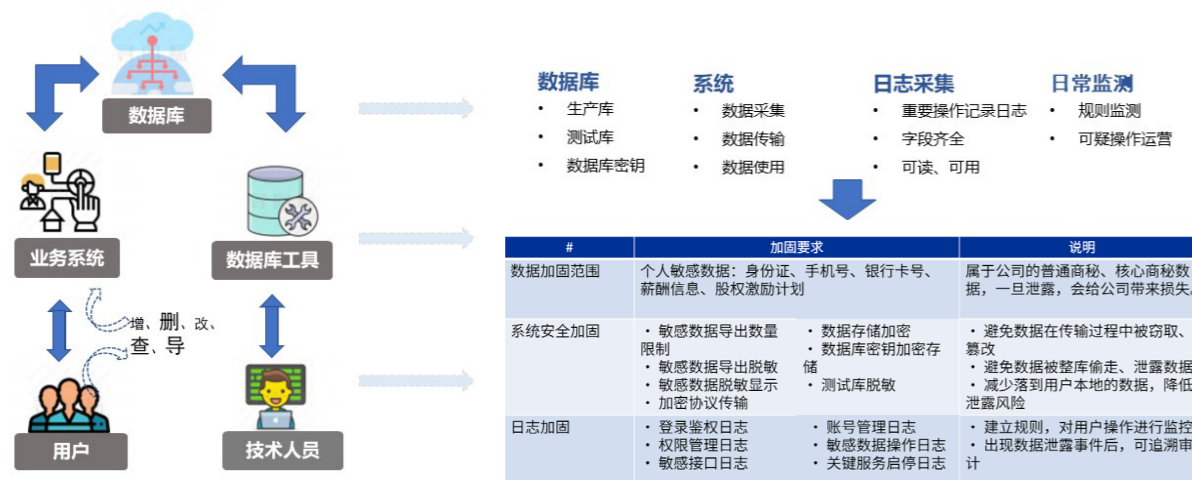

Five Data Security Products



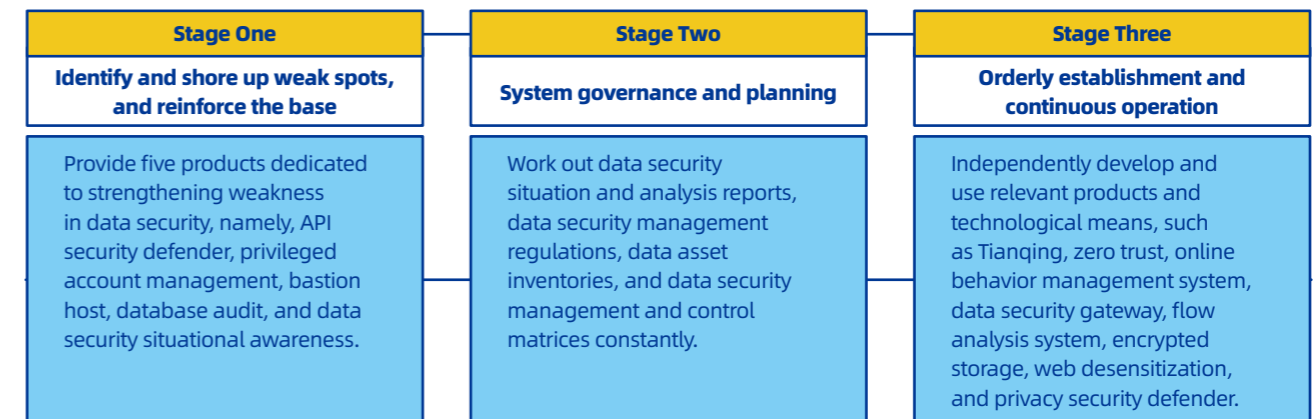
The Reinforcement Requirement of Operation System Data Security

Fostering an Ecology to Safeguard Cyber Security Operation

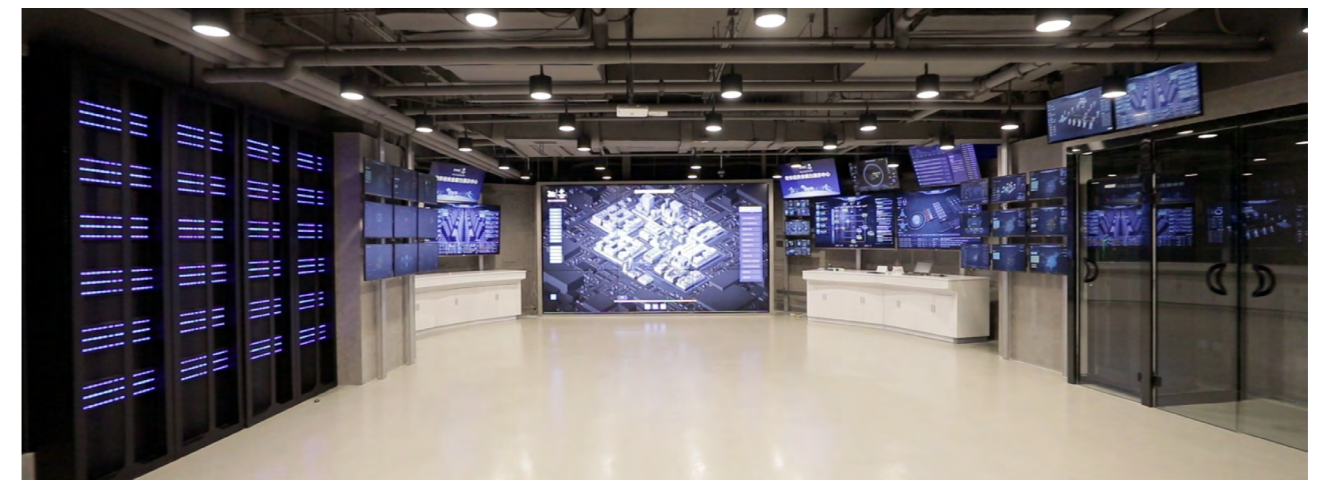

The Company has established the cyber security ecological system centering on data security, product security and training in order to comprehensively ensure secure and stable operation. At the same time, it also enhances the Company's anti-risk capability and business.

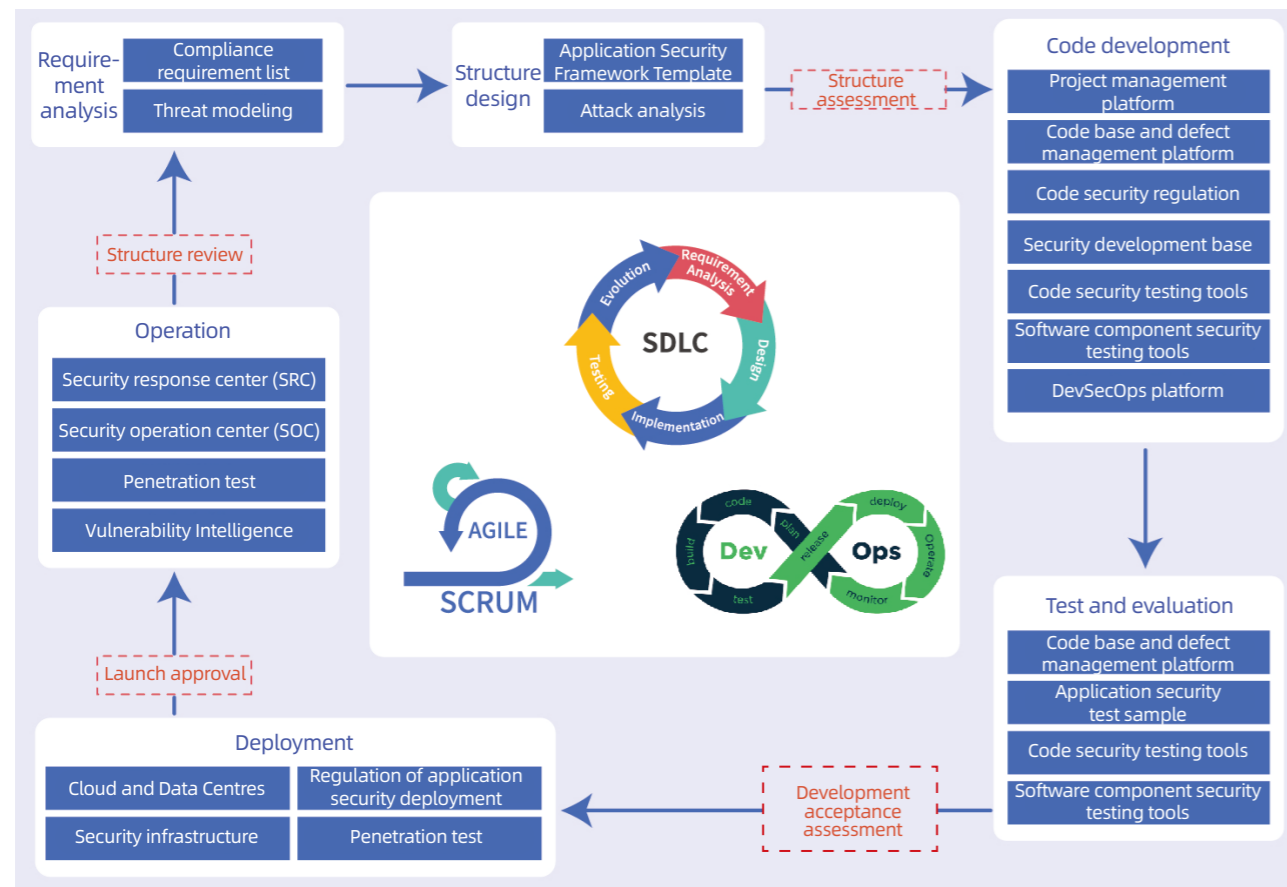
In terms of data security, Qi An Xin has determined the staged data security safeguarding framework. At the first two stages, the Company strives to work on shortcomings and reinforce the base, and at the final stage, it strives for continuous operation.

Three Stages of Qi An Xin Data Security Safeguarding Framework



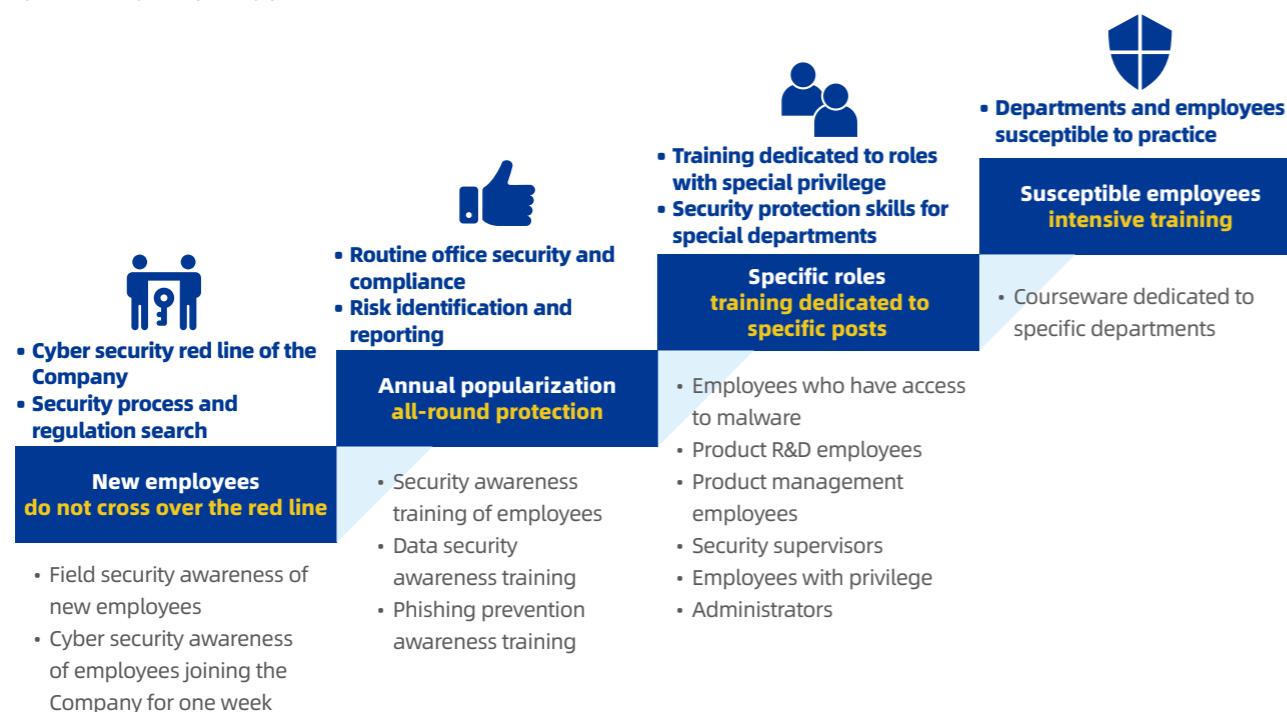
Qi An Xin continuously invests in the product security development system, focusing on its own security during the software life-cycle. With reference to security development practices, such as the security development life cycle (SDL), software assurance maturity model (OpenSMMM), and integrated development security operation and maintenance (DevSecOps), the Company has established a full software security development system, covering aspects such as identification of security requirements, security design, security development, security testing as well as deployment, operation, and maintenance of security. Throughout the R&D life cycle, the Company has introduced security and privacy review and control measures, and adopted automated verification means to enable end-to-end security inspections in the whole process from business requirement identification to product delivery. These efforts aim to enhance product security protection capability and ensure software security.

In terms of training system, Qi An Xin has developed a special cyber security publicity system to improve the security awareness and competence of employees. In the hierarchical training system, Qi An Xin organizes induction training, regular reviews, training dedicated to specific posts, and training for susceptible employees so that every employee can build and maintain awareness on cyber security and privacy protection.

Solidifying the Foundation to Deliver High-quality Services without Accidents

Ensuring business stability is the core focus of cyber security operation and maintenance. Amid the continuous progress of digital development, the Company faces new challenges in its business and its system operation and maintenance. Focusing on the structure with dual server rooms, monitoring and warning, security reinforcement, security safeguarding during periods with skyrocketing needs, and emergency plans, Qi An Xin has pooled its security operation efforts to establish an effective joint mechanism and build an effective support system. Such efforts help to make digital systems more accessible, easier and safer. With the self-adapting endogenous security mechanism, the Company has enhanced the overall operation and maintenance efficiency, and business stability. Therefore, it is able to provide customers with high-quality services while staying free from any accidents.

Dual Server Rooms

To ensure operation stability and improve disaster recovery capability, Qi An Xin furnished server rooms in Shanghai and Beijing with application and data disaster recovery services, and established the structure of dual server rooms enabling disaster recovery in 2022. As a result, the system availability rate reached up to 99.95%. On the one hand, this innovative move reduces losses caused by system faults while cutting routine operation and maintenance costs. On the other hand, it shortens shutdown time. These efforts contribute to the achievement of the goals of strategy approval, seamless switching, safety and stability, providing customers with more effective and better services, thus enhancing the image and value of the Company.

Security Safeguarding during Periods with Skyrocketing Needs

To address surging pressure on digital system stability every three months or at the end of each year with skyrocketing needs, Qi An Xin has made proper arrangements to ensure the stability of 18 systems, together with several departments. At the same time, the Company has tasked personnel with specific jobs to ensure operation stability, and arranged round-the-clock shifts to inspect systems every day. These efforts help the Company to maintain normal business operation, and deliver projects to customers on time, and safeguard the cyber security of society.

Security Reinforcement

Qi An Xin has formulated and implemented warning rules. With reinforcement in encrypted data storage, data masking, and data export restriction, the Company has established a differentiated and precise data protection mechanism, fostering prevention before incidents and post-incident audit and tracing. Thanks to the mechanism, personnel can use data but have no access to data path and data transfer. Hence, it is a great effort to ensure operation stability.

Monitoring and Warning

In 2022, Qi An Xin doubled its efforts to strengthen application service monitoring and warning capability to address application service management problems. To this end, the Company established the full-process warning mechanism covering "warning triggering - real-time notification - recording", changing the pattern from "checking business status by personnel" to "warning personnel of business status automatically". This mechanism effectively reduces faults, shortens fault response time, improves business value, and enhances customer satisfaction.

Emergency Plans

In addition to measures above, Qi An Xin has worked out emergency plans along with multiple actions to ensure stable, continuous and suitable services. The Company has improved disaster recovery plans and backed up data regularly to enable core data recovery in case of natural disasters, cyber-attacks, system faults, or other emergencies. Furthermore, the Company tests systems and running processes regularly to identify potential problems in time. At the same time, the Company also arranges for employees to receive training periodically to increase their service awareness and strengthen their emergency response capability.

Customer Service



Qi An Xin focuses on the technology-based and customer-centered service principle throughout its technical support and service system. The Company has established a comprehensive service system complying with international practices, which includes a strict organizational system, high-quality talent teams and effective service procedures. We provide customers with standard-based services and top-class technical support meeting their needs in a timely manner, forming the cornerstone for us to survive and grow.

Digital Marketing Management

Focusing on the digital integration of marketing resources, the digital marketing management platform remodels customer value, and helps companies reinforce, expand and re-define the customer value chain with the help of information and data analysis. The platform provides digital management and operation tools for the marketing system. With consideration To B business mode in the cyber security industry, we have established the digital marketing network by leveraging big data and artificial intelligence to meet the customer needs of real-time awareness, analysis and prediction, so as to build a benchmark for digital applications in the industry.

At the same time, the Company actively promotes digital price management. In addition to enhancing its own management efficiency, the Company provides excellent practice references for digital marketing management in the cyber security industry and greatly contributes to building the digital benchmark in the cyber security industry.

Intelligent Marketing Management Endpoint



The intelligent marketing management endpoint, an uniform mobile portal for the marketing system (marketing portal), integrates common marketing resources, and works to improve data transparency during the marketing process, enhance business efficiency, and support the strategic development of the Company while helping marketing personnel achieve performance objectives.

In 2022, the Company launched service renewal leads and data visual boards, enabling easy online closed-loop management of service renewal leads, sales performance, and customer management analysis. As of the end of reporting period, this module imported 3,872 service renewal leads for online management, covering nearly 3,000 users. Besides, the Company has reconstructed the product matching quoter in its independently-developed products, enabling the self-help option selection of online products under e-commerce mode, which improves department coordination efficiency and reduces price data leakage risks.

Through digital integration of service channels, the Company has established the user service system featuring agile response to provide targeted and on-demand services throughout the process from order to delivery. This enhances the response capability in the full product life-cycle.

Improving Service Quality

To effectively protect the rights and interests of customers, Qi An Xin has established a comprehensive set of service criteria and service procedures. By far, the Company has been certified for its compliance with the ISO20000 IT Service Management System, ISO9001 Quality Management System, and GB/T27922-2011 Evaluation System for After-sales Service of Commodity (Five-star). We make unremitting efforts to improve the quality of service and protect the rights and interests of customers.

※ Releasing the First Short-number Cyber Security Hotline in China 95015

In 2022, Qi An Xin released the first short-number cyber security hotline (95015) in China, replacing the previous emergency response hotline, the customer service hotline and the partner hotline, which marks an important upgrade in online cyber security service. The combination of this all-in-one hotline, the emergency command platform, the customer service center and the monitoring and dispatching center enhances efficiency sharply and delivers better security protection services to customers nationwide.

※ Upgrading Service Quality Criteria

In 2022, Qi An Xin published the *Qi An Xin Management Measures for SLA Fault Grading Service Quality Criteria V3.0*. This document redefines and optimizes customer service response and solution timeliness, and specifies stricter service requirements and criteria to provide customers with faster, better and more effective services.

※ Establishing the Intelligent Customer Problem Management System

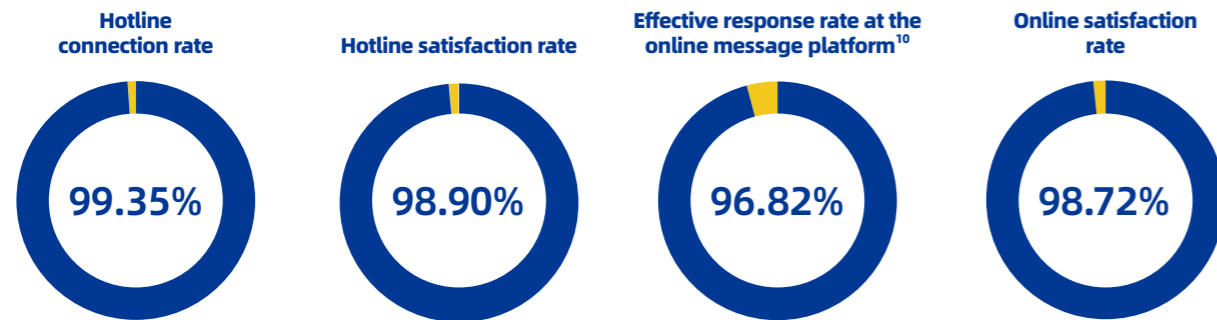
In 2022, Qi An Xin carried out comprehensive upgrades and transformations of its customer issues management system to enable full-cycle monitoring and tracking of customer issues in all dimensions from initiation to resolution. With the combination of the Company's proprietary BI, intelligent robots and other tools for comprehensive digital warning, analysis and management of customer issues, the Company has improved the efficiency of customer issue resolution and service quality.

※ Giving a Listening Ear to Customers' Needs

Currently, Qi An Xin has multiple streamlined customer feedback channels and support platforms, such as 95015 hotline, online message platform, and email. The Company has established effective customer feedback management criteria and procedures. Our customer service personnel handle and trace customer feedback according to the SLA standard in order to ensure each piece of customer feedback is settled to customer's satisfaction.

Customer Privacy Protection

Improving customer privacy protection is an important part of the further development of intelligence and information technology. To strengthen the protection of user and customer privacy security, Qi An Xin has formulated a series of documents including the *Qi An Xin Management Rules for Personal Information Security*, the *Qi An Xin Operating Procedures for Data Masking*, the *Work Safety Management Requirements*, and the *Management Measures for the Conducts of After-sales Services*. Based on these documents, we make efforts to control the privacy management during the service, protect customers' right to knowledge, and organized more privacy protection awareness training sessions for employees in order to protect the personal privacy data of customers and continuously enhance their experience.

※ Protecting Customers' rights and interests

Customers are entitled to the ownership and control of their personal information and the right to be informed of how the Company handles customer information and data. All Qi An Xin products are equipped with a user privacy policy, which clearly states in detail how data is collected and how it is used, as well as how their privacy is protected. This ensures that the security of customer privacy and the transparency of the use of customer data are continuously improved, thereby protecting customers' right to information.

Qi An Xin's Future Plans for Customer Privacy Protection

Unified Privacy Protection Policy

To achieve effective protection at the infrastructure level with the Company's "Five Elements of Data Security", we restrict the use of data to the intended location and within the permitted personnel in order to achieve the goal of making data usable yet non-spreadable, with all retention of data prohibited.

Variability in Implementation

Adopting the strategy of "available but not viewable" to ensure data security of business systems, we formulated customized implementation plans with the characteristics of business systems. Examples include product iteration for self-developed systems to achieve desensitization of sensitive personal information, as well as data security gateways to achieve desensitization of sensitive personal information in business systems with limited product iteration.

※ Implementation of Privacy and Security Management

To protect customer privacy and reduce business risks, Qi An Xin mandate all its employees in terms of safety awareness, behaviors and confidentiality based on the *Work Safety Management Requirements*, in order to effectively protect the privacy and security of customer.

※ Organizing More Privacy Awareness Training

Qi An Xin firmly enforces the privacy awareness promotion system and regularly organizes reviews of safety production cases for employees to continuously increase their awareness on privacy protection. In addition, the Company requires all employees to complete the study and assessment of the content of the Company's Production Safety and Privacy Protection Requirements by means of on-site training or online videos followed by online assessments. Newly recruited employees are required to complete the production safety assessment within 7 days.

Promoting Integration and Co-construction to Empower the Sustainable Development of the Value Chain

In addition to promoting technological advancement and meeting customer needs for digital transformation and cyber security protection, Qi An Xin undertakes its social responsibility by utilizing its technological advantages to boost industry development and create shared value for the industry. The Company has established a full-process supply chain management system to grow together with partners in the value chain. Being the pioneer in the industry, the Company remains committed to promoting partner development and industry talent cultivation with our rich experience. It also proactively participates in industry exchanges and standards formulation to empower the industry and pursue win-win cooperation.

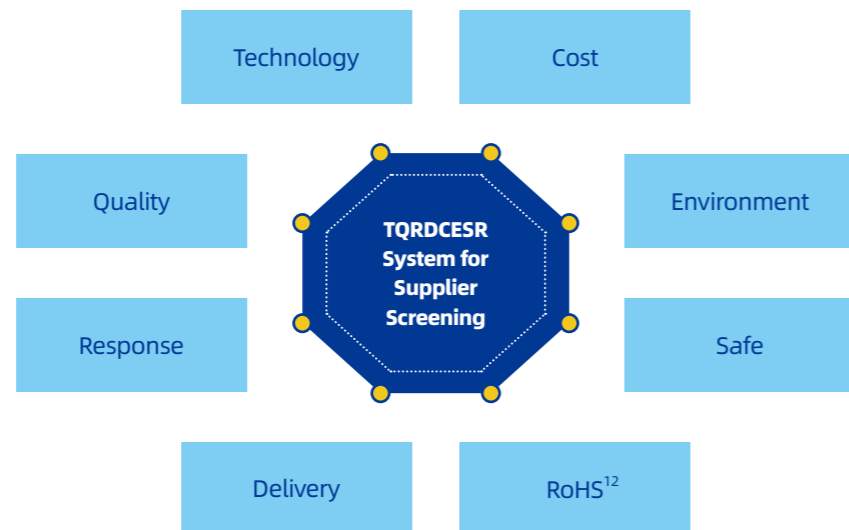

Supply Chain Management

As consistent good performance of suppliers is the basis to ensure stable operation of an enterprise, Qi An Xin has established a supplier management system with reference to best industry practices. The Company has formulated internal management regulations including the *Qi An Xin Measurement Measures for Procurement in the Supply Chain*, the *Qi An Xin Measurement Measures for Suppliers in the Supply Chain*, the *Qi An Xin Management Procedures for Certification of Raw Material Suppliers*. These documents clarify the allocation of management responsibilities, supplier relationship management, access criteria, performance assessment and training activities. In 2022, Qi An Xin cooperated with 125 raw material suppliers.



For standardization and efficient management of supplier evaluation and strict control of supplier quality, Qi An Xin has established comprehensive differentiated supplier evaluation procedures and assessment methods. In terms of supplier application, the Company requires potential suppliers to fill in the Supplier Survey Form, and present true and valid basic qualifications and credentials. In terms of supplier assessment, Qi An Xin organizes a supplier assessment committee to assess potential suppliers with reference to the TQRDCESR matrix and the Supplier Scoring Form, with priority given to suppliers with the highest scores. Our suppliers are required to sign the Commitment to Integrity and comply with our procurement ethics and regulations on anti-fraud.

Supplier Management

In routine management, Qi An Xin highlights the development of supplier capability through auditing. The Company has set up a supplier assessment team comprising members from the Procurement Department of the Business and Supply Chain Center, the Product Business Department, the Quality Control Department, and the Customer Service Expert Department. The committee will assess supplier performance regularly according to the categories of suppliers.

Apart from routine annual audits, Qi An Xin has established an interim audit mechanism that allows supplier quality engineers (SQE) from the Business and Supply Chain Center to conduct issue audits as needed. According to performance evaluation results, suppliers are classified into three categories, namely excellent, qualified and unqualified.

To give play to the feedback and incentive function of performance assessment, Qi An Xin incorporates supplier performance into business performance assessment, and apply the mechanism to suppliers in the phases off selection, bidding and portfolio management. Under the same conditions, suppliers with excellent performance will be given priority in supply share or granted more business cooperation opportunities. Meanwhile, suppliers with unsatisfactory performance will be required to make rectification within limited time and be entitled to less supply share and limited business cooperation opportunities. Suppliers failing to pass assessment twice will be removed from the shortlist.

Improving Supplier Capacity

Qi An Xin also attaches importance to the improvement of supplier capacity. To this end, the Company organizes training and tutoring for suppliers according to the categories they are classified into, so as to help them enhance operation efficiency and supply capacity. Hence, this will reduce procurement risks, and form a supply chain with mutual benefits upon cooperation.

Software and Hardware Supplier Training 

With a strong focus on building supplier capacity, Qi An Xin has organized several online training activities centered on topics like quality standards, quality objectives and quality management methods for hardware suppliers in 2022. Meanwhile, the OEM software supplier quality management team provided important control software suppliers with online training activities specific to the *Qi An Xin Management Regulations on OEM Software Quality*, the *Project Management*, the *Root Cause Analysis*, and the *Test Management*.

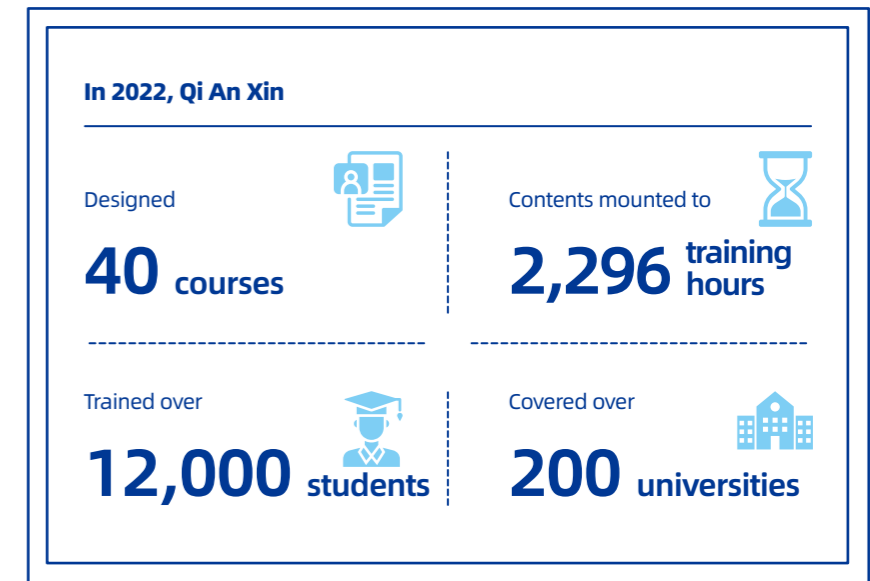

※ Developing Practical Courses

Relying on its solid cyber security capability and discipline teaching standards, Qi An Xin has established a full cyber security course system, which covers basic cyber security knowledge, cryptography knowledge, cyber security expertise, system security knowledge, and content security knowledge. Balancing theoretical knowledge and practical skills, the system aims to cultivate the all-rounded cyber security capabilities of trainees.



Driving the Industry Development 

As network technologies develop rapidly along with increasingly prominent cyber security issues, the shortage of cyber security talents and the limitation of industry technologies have been two major factors restricting the information-based development and cyber security improvement in China. As the largest cyber security company in China, Qi An Xin is committed to fostering a healthy ecosystem and leading the development of the industry. Therefore, Qi An Xin has taken combined measures in talent cultivation and industry exchange over years, and called for joint efforts to share a future with safe cyberspace.

Cultivating Cyber Security Talents

The cultivation of cyber security talents is a national strategy and an integral part of the industrial ecology. Thus, Qi An Xin remains focused on the cultivation of cyber security talents in the long run. Adhering to the principle of "systematic, hierarchical, and professional talent training for the long term", the Company has incorporated cyber security education and training into its important development strategy amid cyber security evolution, in order to facilitate the comprehensive improvement of cyber security capacity nationwide while boosting the growth of cyber security talents.

※ Implementing Practical Teaching

Based on its rich cyber security real-word case library, Qi An Xin continues to formulate and introduce new teaching methods. Meanwhile, the Company focuses on practical teaching and case studies, by organizing capstones on simulated network attacks, risk assessment, security policy formulation, and security design realization to effectively improve the practical skills of trainees. In addition, the Company studies cyber security cases such as information system integration, security product integration, application security protection, security operation and maintenance, security operation, classified protection evaluation, and penetration testing to improve the capability of trainees.

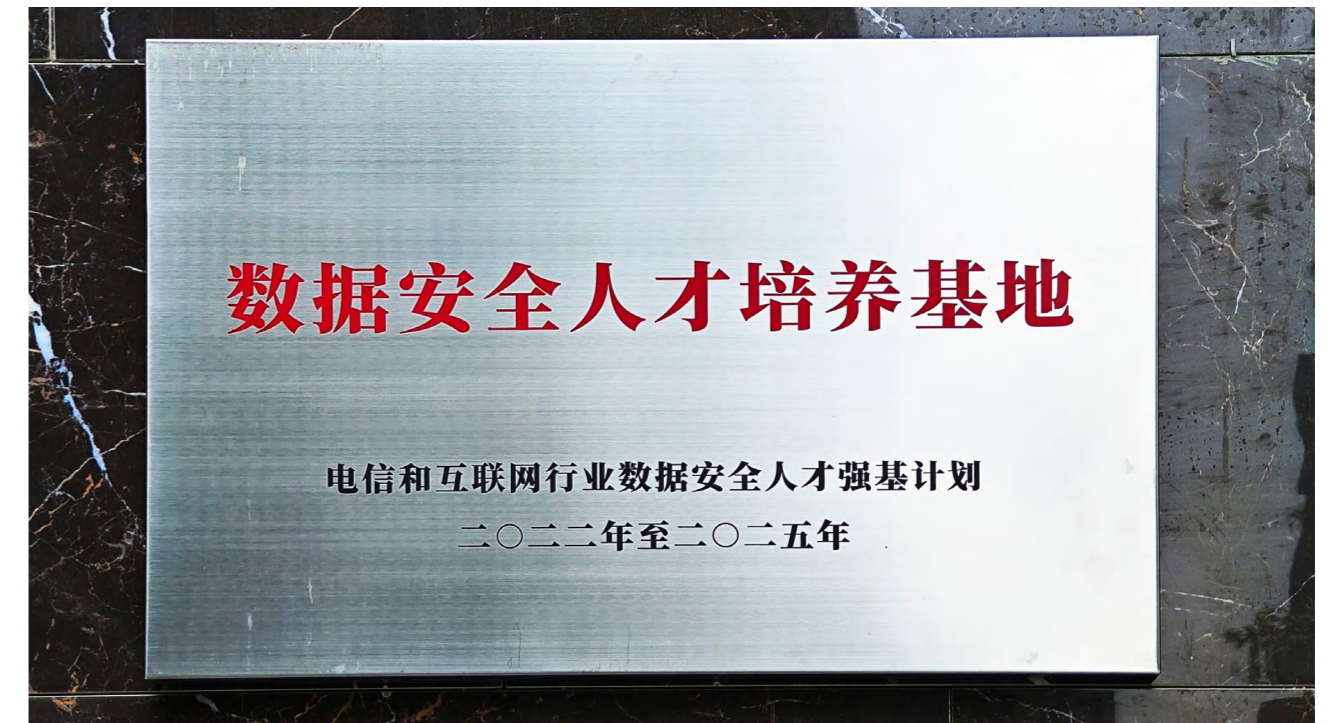
Consolidating the Practical Skills of In-service Employees



With the rapid development of information technology, improving the skills of onboard cybersecurity employees and the cyber security awareness of administrators is critical to cyber security in the new era. To this end, Qi An Xin has set up courses that integrate cutting-edge technology and business, such as the *Enterprise Network Penetration Test*, the *Enterprise Network Security Evaluation*, the *Enterprise Network Security Operation*, the *Enterprise Network Security Operation and Maintenance*, the *Development of Enterprise Network and its Services*, the *Enterprise Network Application Security Protection*, and the *Enterprise Network Security Product Integration*, with the aim to improve the practical cyber security skills of in-service employees systematically. In 2022, the Company designed 24 practical courses amounting to 992 teaching hours.

※ Tiger Tally Base

The Qi An Xin Tiger Tally Base focuses efforts on the training of cyber security talents engaging in cyber security operation and services at all levels for enterprise and public institutions. As of the end of 2022, the Qi An Xin Tiger Tally Base has offered 62 classes in total, and trained 3,756 cyber security talents, including 1,339 engineers assigned to Qi An Xin. Our customers include institutions and companies in the financial, educational, transport, communication, energy, and government sectors in more than 100 cities such as Beijing, Shanghai, Guangzhou and Shenzhen. In 2022, the Base was included into the first batch of the Data Security Talent Training Bases in the Telecom and Internet Industry Talent Strengthening Program.

On the basis of the Tiger Tally Base course development, Qi An Xin has established a multi-level cyber security talent competency and quality profile model to enhance the actual operational capabilities of talents while creating a multi-dimensional talent selection and evaluation system. The innovative evaluation system provides an optimized iteration of the training system and selection mechanism, enabling further filtering and identification of cyber security talents who are "technically qualified, provide standardized services, provide rapid response, and maintain confidentiality and reliability". This contributes to the development of industry talents. In 2022, the Qi An Xin Tiger Tally Base was named the "Supporting Organization for Evaluation of Talent Competency in Key Fields of Industry and Information Technology".

※ **Tiger Tally Cyber Security Training Camp**

Qi An Xin is committed to discovering and cultivating top security talents. Focusing on the sharing of advanced practical cyber security technologies, the Tiger Tally Cyber Security Training Camp sets up practical courses to effectively improve the practical attack and defense skills of trainees and provide the cyber security industry with middle- and top-tier cyber security talents. Since 2014, the Tiger Tally Cyber Security Training Camp has been successfully held for 9 sessions. As a top professional training institution in cyber security, Qi An Xin has developed more than 80 high-end training courses and trained more than 2,500 trainees.

"Zero-incident Master Class" and "Security Elite Class" 📺 📺 📺

In 2022, the Tiger Tally Cyber Security Training Camp launched the "Zero-incident Master Class" and the "Security Elite Class". These two classes consisted of 19 courses, with a total enrolment of 649 trainees.

Zero-incident Master Class: Combining the zero-incident cyber security requirements of the Beijing Winter Olympics and the Company's rich cyber security experience, Qi An Xin has set up this class dedicated to the front-line attack and defense technicians. This class studies real zero-incident cases, and teaches courses in practical attack and defense, and threat monitoring, among others.

Security Elite Class: Dedicated to university students and prospective security industry practitioners, this class covers the teaching of systematic basic skills and the training of advanced cyber security capability improvement to provide high-quality talents for the cyber security industry.



Facilitating Close Cooperation among Enterprises, Universities and Research Institutions





A diversified university-enterprise cooperation mechanism can help promote the sharing of educational resources and complementary advantages among the parties concerned while enhancing effective and targeted education. Attaching great importance to university-enterprise cooperation, Qi An Xin has organized various cooperation activities, from joint training to practice bases. With platform advantages and continuous industry experience sharing, Qi An Xin has facilitated close cooperation among enterprises, universities and research institutions.

※ **Practice Base upon Enterprise-University-Research Institution Cooperation**

Since 2019, Qi An Xin has been cooperating with universities to build a security talent training system and establish professional practice training bases dedicated to undergraduates or above. At present, the Company has signed agreements on joint training and practice bases for postgraduates with universities such as Tsinghua University, Shanghai Jiao Tong University, Southeast University, Ocean University of China, and Beijing University of Technology, to train Master's and doctoral students in engineering. As of the end of 2022, more than 80 Master's students and 20 doctoral students have enrolled on the practice training bases.

To improve the practical skills of students, the senior researchers from Qi An Xin Technology Institute serve as external supervisors who guide students in thesis writing. In 2022, over 10 postgraduates completed theses and their defenses under the supervision of these senior researchers. The Technology Institute also provides internship opportunities for undergraduates, and master and doctoral students, which last half a year, one year or two years. The internship programs aim to cultivate the students' ability to solve practical problems in real development, and train high-end technical, innovative and inter-disciplinary talents in cyber security jointly with universities. In 2022, more than 30 master and doctoral students worked as interns in the Technology Institute.

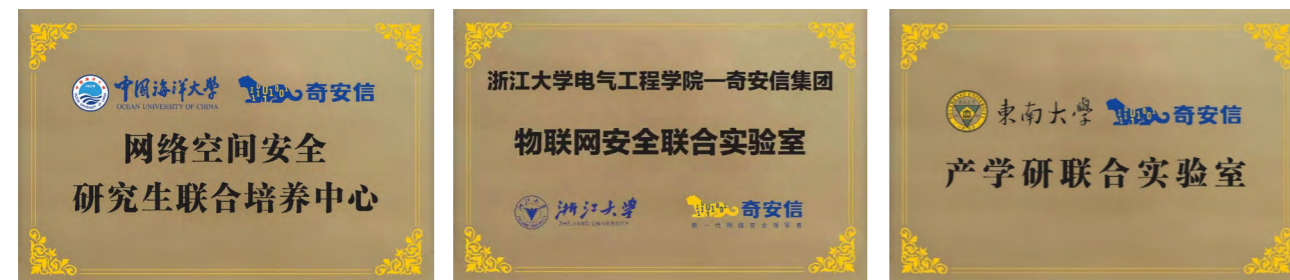

※ **Training Reform Program for Master's and Doctoral Students in Engineering**

In 2022, Qi An Xin actively engaged in the training of top-tier cyber security talents. Responding to the "Training Reform Program for Masters and Doctors in Engineering" jointly initiated by nine ministries and commissions, and the "University-enterprise Joint Training Program for High-level Cyber Security Talents Urgently Needed by the State" launched by the Office of the Central Cyberspace Affairs Commission, the Company admitted 22 and 14 Master's and doctoral students in engineering who enrolled in 2022 and will enroll in 2023 respectively, and set up the Excellent Engineer Base. For the base, the Company assigned 10 Master's and doctoral supervisors in scientific and technological innovation and over 30 key technical employees and researchers to constitute the supervisor panel.

※ **University-enterprise Joint Laboratory**

As the industry development depends on fundamental research, Qi An Xin is well aware of the importance of research in universities. In 2022, Qi An Xin established joint laboratories in basic and applied research, cooperating with universities and scientific research institutes such as Tsinghua University, Shanghai Jiao Tong University, Zhejiang University, the Institute of Software, Chinese Academy of Sciences (ISCAS), and Shandong University. These joint labs focus on researches on internet infrastructure, protocol security, detection analysis, data-driven security, malware analysis and vulnerability mining, Internet of Things/Internet of Vehicles, 5G and other emerging cyber security technologies. In 2022, these joint labs published 12 papers in the top four international security summits (such as CCS and USENIX), and important international conferences.



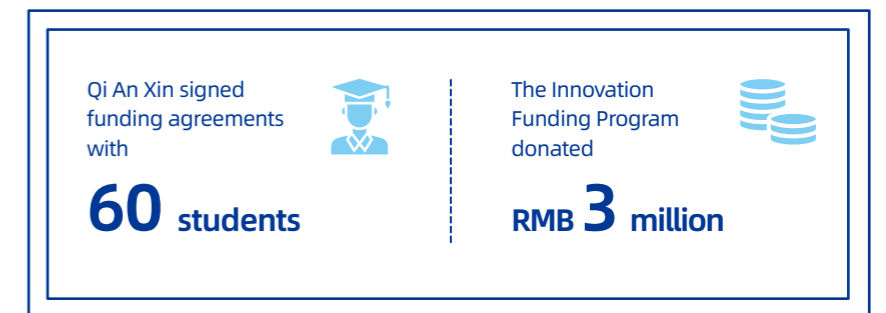
※ **Teaching and Research Platform**

The teaching and scientific research platform not only provides students with more development space, but also plays as an important innovation-driven force. In 2022, Qi An Xin teamed up with Tsinghua University, Shandong University, Sun Yat-sen University, Nankai University, and Nanjing University of Information Science and Technology to develop XX excellent teaching courses in data security, cryptography, and software security, which injects inexhaustible impetus and vitality into cyber security talent cultivation.

※ **Innovation Funding Program**

Under the guidance of the Office of the Central Cyberspace Affairs Commission, Qi An Xin, together with multiple partners including 10 first-class colleges specializing in cyber security, Cyber Security Association of China, and China Internet Development Foundation, launched the Innovation Funding Program for Cyber Security College Students to encourage students to forge ahead and achieve breakthroughs in cyber security innovation.

In 2022, Qi An Xin screened and released 60 excellent subjects out of 166 innovation subjects collected upon evaluation by experts. These topics covered five major aspects, namely security detection, identification analysis, data governance, emerging technologies, and intelligence response. After evaluating 218 applications from universities, Qi An Xin signed funding agreements with 60 university students and earmarked up to RMB 3 million.

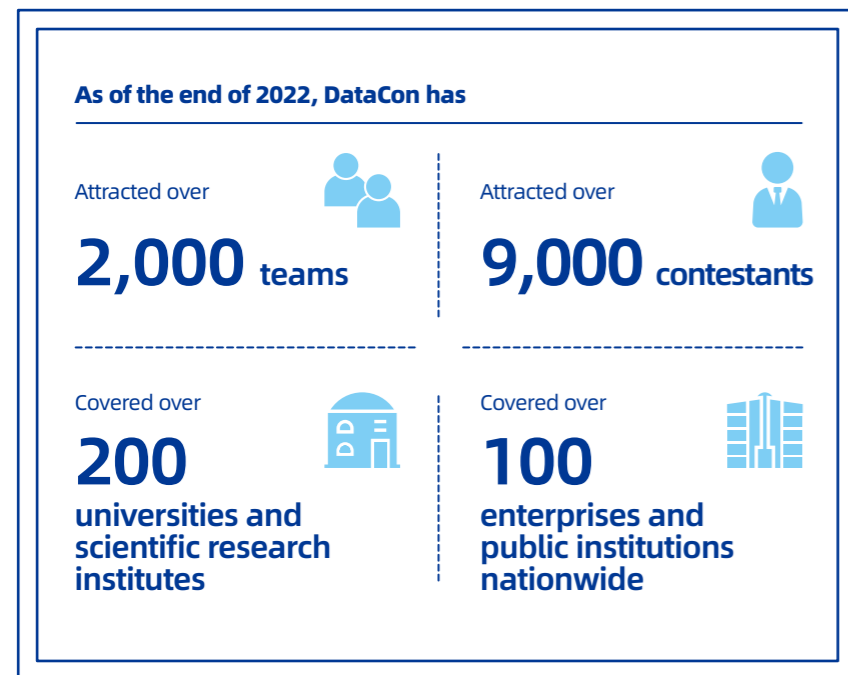


Encouraging Innovation and Cooperation through Competitions

Competitions are the best platform for putting theoretical knowledge into practice, and an important way to promote industry development. Essentially, cyber security involves attack-defense confrontation. Competitions are a necessary means and basis to build and improve attack-defense capability in real-world scenarios, so as to foster practical cyber security capability. Emphasizing the importance of practical attack-defense drills, Qi An Xin actively organizes or participates in various cyber security and data security competitions. Advocating cooperation and innovation, the Company has set up several national benchmark competitions, and attracted talents from various industries nationwide.

※ DataCon2022 Big Data Security Analysis Competition

In 2022, Qi An Xin hosted the DataCon Big Data Security Analysis Competition, the first practical competition in inter-disciplines of security, data and artificial intelligence in China. The event was held in collaboration with Institute for Network Sciences and Cyberspace of Tsinghua University, Ant Group, Tencent Security Big Data Lab, Coremail. This event attracted 1,580 competitors from 662 teams from more than 370 universities, scientific research institutes, enterprises and public institutions all over the state. With real network data, the competition simulates the real-world cyberspace. As an innovative move, the competition shared scientific research data sets with teachers and students in universities for scientific research and teaching experiment.



A Summer Camp Jointly hosted by DataCon and InForSec at Southeast University



In early August 2022, the InForSec "Cyberspace Security" Summer Camp for University Students and the First DataCon Special Training Camp were successfully held at Southeast University, which attracted more than 100 guests and students attending the event online and in person. The Summer Camp offered courses focusing on attack-defense confrontation and cyber security competitions. The DataCon Special Training Camp had one cyber security class and one system security class to help students understand and master competition skills and relevant expertise.



Besides, the camps provided training and tutoring specific to data security analysis capabilities in terms of network traffic analysis, domain name system security, software security, and Internet of Things vulnerability mining, in order to improve the comprehensive abilities of trainees to solve practical problems from the perspective of big data. In this Summer Camp, trainees ranged from sophomore-year students to second-year doctoral students, all of whom were from 61 universities including Tsinghua University, Beihang University, Beijing University of Posts and Telecommunications, and Shandong University.



※ "Lanmao Cup" Cyber Security Skills Competition of University Students

Qi An Xin has hosted the "Lanmao Cup" Cyber Security Skills Competition for University Students 6 times, which is the first network security skills competition that deeply integrates offensive and defensive confrontation and electronic forensics business scenarios. The Company takes the full-process training mode covering talent selection, cultivation and employment to provide practical cyber security professionals for the major national institutions and organs. In 2022, the Competition admitted 3,232 competitors from 1,230 teams.



※ Tiger Tally Cyber Security Competition

Embracing the industry development trend that strikes a balance between security and development, the Tiger Tally Cyber Security Competition has been consistently introducing new competition systems and attack-defense drills over years to train talent teams from various industries. In 2022, focusing on data security scenarios, the Competition launched the online double competition systems covering AWD Plus attack and defense, and PKS system contest for the first time, attracting 3,072 competitors from 800 teams.

※ Provincial-level Competitions

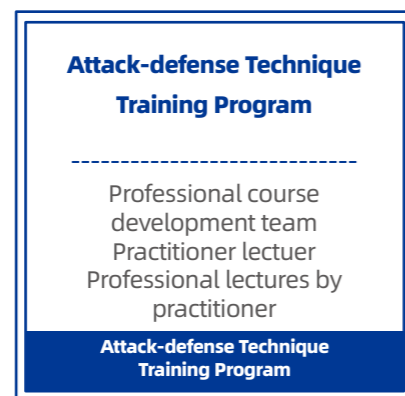
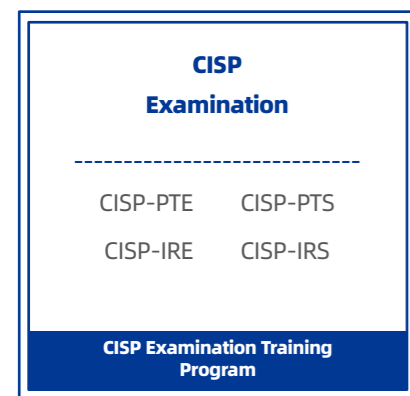


Certification System to Close the Training Loop

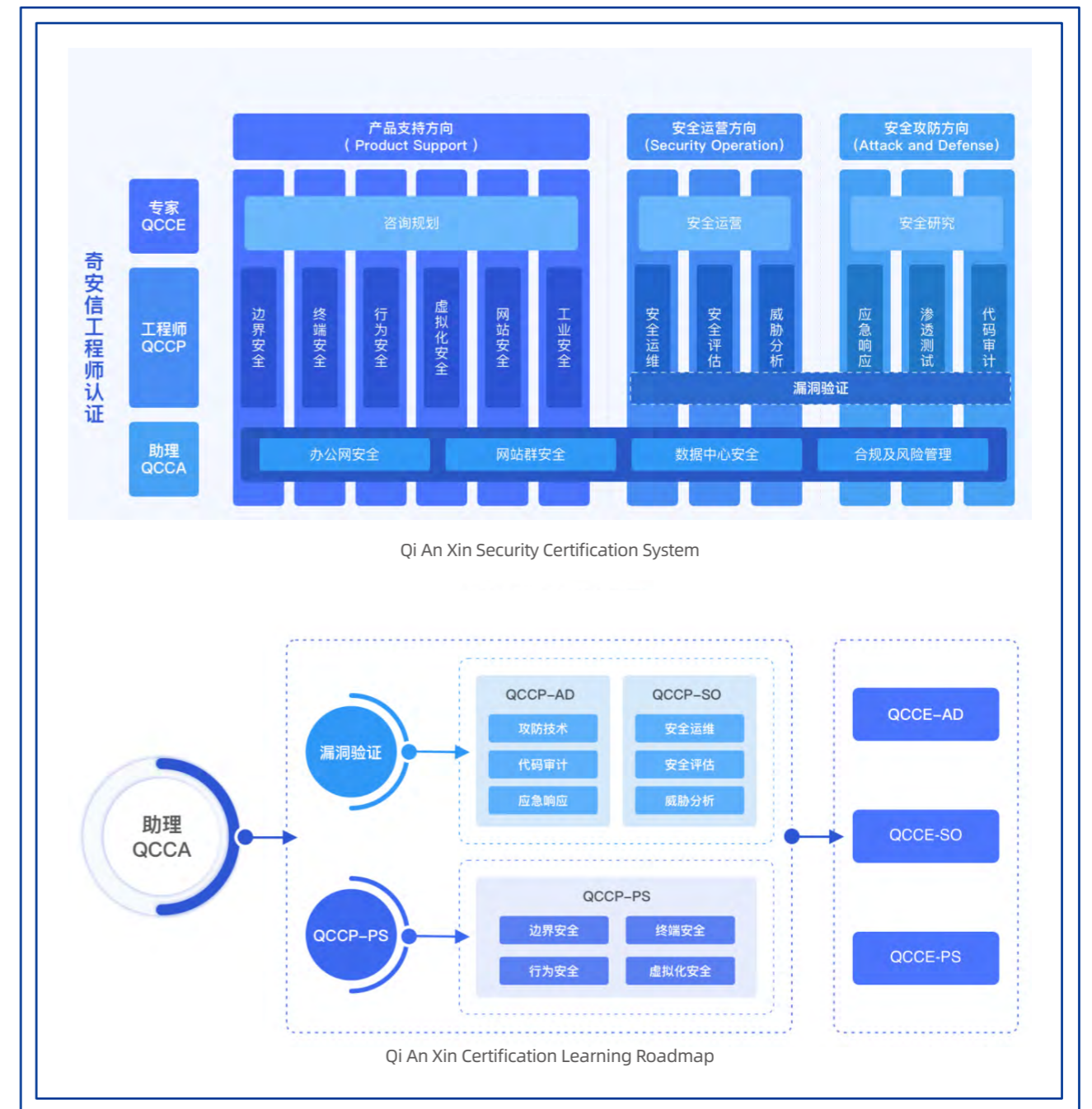
※ Industry Certification Training

With cutting-edge technology advantage and great influence in the cyber security industry, Qi An Xin is now one of the top cyber security service providers with high reputation and strong technical strength in China. As a CISP training institution authorized by the China Information Technology Security Evaluation Center, Qi An Xin engages several cyber security experts to provide enterprises and individuals with high-quality CISP registration as well as training for examination and attack-defense technique. Its certification training efforts will cultivate excellent cyber security talents for customers, reserve more high-end cyber security talents, and help customers establish hierarchical cyber security talent training systems to meet their own cyber security requirements.



※ Qi An Xin Certification System

Relying on its cyber security talent training experience and extensive knowledge of industry development, Qi An Xin has designed and built a cyber security talent training, registration and assessment system covering all technical fields of cyberspace security. The system, Qi An Xin Cyberspace Security Engineer Certification System, contributes to the national cyberspace security strategy while meeting need for cyber security talents of enterprises. The system aims to serve as a guide for the education and training of all-rounded practical cyber security talents. In recent years, the Company has been optimizing its Security Certification System, and is expected to upgrade the system in 2023.



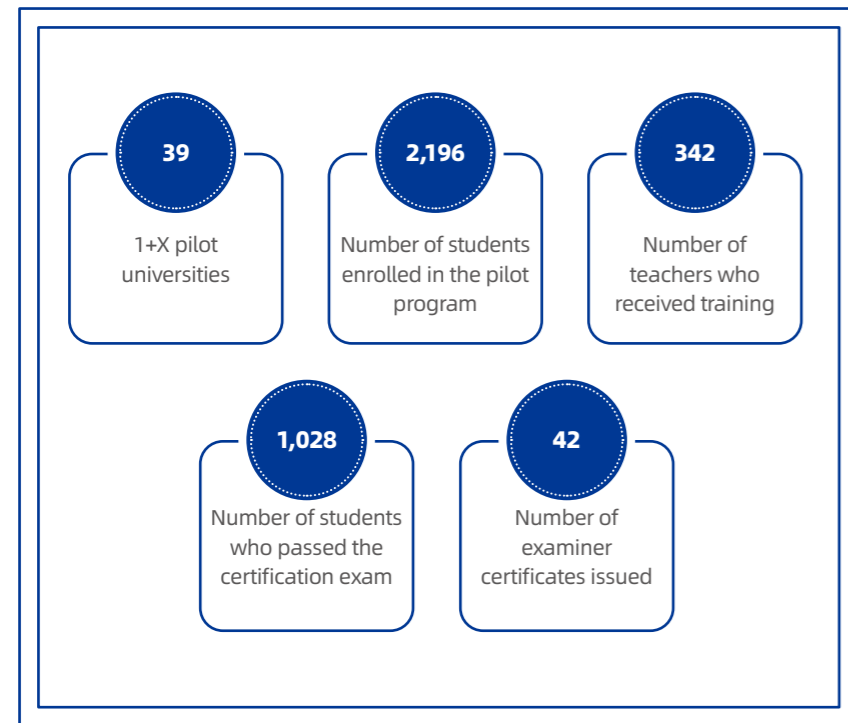
※ **1+X Certification System**

To implement the 2019 Implementation Plan for the Reform of the National Polytechnic Education, the 2020 Education Information-based Reform and Work Focuses of Cyber Security, the Plan for Pilot Program of Academic Certificates + Several Vocational Skill Level Certificates in Universities, the Guiding Opinions on Promoting Pilot Program of 1+X Certificates, and the Notice on Organizing the Training of Teachers in Universities for the Pilot Program of 1+X Certificates, Qi An Xin has sponsored and designed the 1+X Vocational Skill Level Certificates of Cyber Security Emergency Response, as a supplement to academic certificates, thus facilitating the integration of industrial development and education.

In 2022, Qi An Xin issued 1,028 "1+X" certificates of various types, including 827 Vocational Skill Level Certificates of Cyber Security Emergency Response and 201 Vocational Skill Level Certificates of Cloud Security Operation Services.

Cooperating with Peers to Promote Exchanges and Establish Standards

Industry exchanges are an important way to promote communication and cooperation among enterprises and enhance industrial competitiveness. With a positive and open mindset, Qi An Xin joins hands with partners to promote the coordinated development of the industry chain. We regularly hold and participate in industry seminars, symposiums, cooperative research, and discussions about multi-party business cooperation models to drive innovation and progress in various fields. In 2022, Qi An Xin held and attended more than 20 industry exchange meetings.

2022 MOSEC Mobile Security Technology Summit

In November 2022, Pangu Lab co-hosted the 2022 MOSEC Mobile Security Technology Summit with the POC of the Republic of Korea. Focusing on high-quality security technology, cutting-edge technical issues and development trends in mobile security were discussed during the summit. At the summit, hundreds of top white-hat hackers and industry experts in the field of mobile security engaged in extensive discussion of several topics, such as vulnerability mining and utilization, and security protection of mobile software and hardware products including iOS, Android, in-vehicle infotainment systems, and SoC chips.



InForSec International Cyber Security Forum

In 2022, Qi An Xin held 8 medium-sized academic seminars in collaboration with InForSec International Cyber Security Forum. More than 50 top cyber security experts from China and abroad were invited for academic exchange and sharing. Over 9,600 security research experts from domestic and foreign universities, scientific research institutes and enterprises also attended these seminars online.



2022 Seminar on Security Services for State-owned Enterprises during Important Periods and Security Operation

In September 2022, Qi An Xin was invited to host the 2022 Seminar on Security Services for State-owned Enterprises during Important Periods and Security Operation. During the Seminar, attendees exchanged ideas and shared on topics such as new security system practices amid digital transformation of enterprises, the "Zero Incidence" security protection experience of Beijing Winter Olympics, the core strategy of security tasks for the 20th National Congress of CPC, and cyber security developments.



In addition, Qi An Xin has actively participated in the establishment of industrial standards. In 2022, several national standards of information security that the Company involved in drafting were published, including the *Information Security Technology—Security Technical Requirements and Testing Assessment Approaches for Network Vulnerability Scanners*, the *Information Security Technology—Guidelines of Cyber Security Protection for Important Industrial Control Systems*, the *Management Requirements for Cyber Security of Industrial Control Systems in Nuclear Power Plant*, the *Technical Requirements for Cyber-physical Fusion Anomaly Detection Specification of Industrial Control System*, and the *Information Security Technology—Information Security Service—Classification and Code*. In addition, Qi An Xin was a drafting participant of the *Information Security Technology—Zero Trust Reference Architecture*, and the *Specification for Human Resources and Social Security Network Security Monitoring and Emergency Disposal*, an industrial standard.



Gathering Experience to Simulate the Industry Vitality

To promote industry development, Qi An Xin continues to accumulate industry experience and has built the Butian Vulnerability Response Platform alongside the release of several industrial reports. From talents to expertise, we make extensive efforts to fully empower industry development and stimulate industry vitality.

Faced with issues like severe shortage of cyber security talents and insufficient security capabilities of governments and enterprises, Qi An Xin has established the Butian Vulnerability Response Platform ("Butian Platform"), which focuses on vulnerability response. As a pilot program for Qi An Xin to strike a balance between economic value and social value, the Butian Platform provides accurate and detailed vulnerability intelligence for society by pooling online security forces to help organizations discover vulnerabilities in time and respond to them quickly. Besides, the Butian Platform mobilizes and guides white-hat hackers to safeguard the cyber security of China firmly and reliably as volunteers through the creation of a practical learning environment while building a tutoring mechanism of supervisors and developing a knowledge and skill system.

The Butian Platform is a constructive attempt at new model exploration by Qi An Xin in the field of social governance. Over the past ten years since its establishment, Butian Platform has become the largest Chinese vulnerability platform and one of the top three vulnerability platforms in the world. It is also one of the most active communication platforms for cyber security professionals. At Butian Platform, the Company has organized various activities such as the Attack-defense Community, the HACK for Security event, the "Butian Cup" Cracking Competition, the Butian Salon, and the Butian Campus Tour. As a result, the Platform has grown into a platform for industry exchange, which attracts numerous domestic and foreign cyber security experts, industry masters, security vendors, and research institutes, thus promoting a better technological ecosystem for cyber security.

Data Security Risk Analysis Report for Chinese Government and Enterprise Organizations

The Qi An Xin Industry Security Research Center conducted a comprehensive study on data security risks for governments and businesses in collaboration with Tianji Partners, Butian Vulnerability Response Platform, Qi An Xin Security Service Team, Qi An Xin Security Monitoring and Response Center, and Qi An Xin Data Security subsidiary, in order to better understand data security risks and status for governments and enterprises. An in-depth analysis of data security (including data leakage, data tampering, and data destruction) is provided in this study. From several perspectives, this study examines public incidents, emergency incidents, website vulnerabilities, dark web risks, and digital brand threats in China's government and enterprise organizations.



Adhering to People-oriented Principle and Growing Together with Employees

Adhering to the people-oriented principle, Qi An Xin attracts and retains talents with an open, equal and inclusive mindset with due respect and protection of the lawful rights and interests of employees. The Company provides a professional platform for stable and holistic development of employees, while fostering a fair, respectful, caring, healthy, safe and harmonious workplace.

As of the end of 2022, Qi An Xin has employed nearly 10,000 security talents, boasting of the largest professional team in cyber security. Together with our employees, we work towards shared progress.

Rights and Interests of Employees

The employee body of an enterprise is its most valuable asset and the cornerstone for its sustainable development. To protect the rights and interests of all employees, Qi An Xin has established an employment mechanism that is in compliance with the laws and regulations. At the same time, the Company also persistently advocates an equal, respectful and diversified workplace to enhance the employees' sense of belonging while continuously upgrading the remuneration and benefits granted to employees, so as to build a harmonious and stable labor relationship.

Equal Employment

In line with the Labor Law of the People's Republic of China, the Social Insurance Law of the People's Republic of China, the Universal Declaration of Human Rights, and International Labor Conventions, Qi An Xin has formulated management regulations such as the Qi An Xin Group Employee Handbook and the Qi An Xin Employee Discipline Regulations. Furthermore, the Company signs labor contracts with employees in compliance with the law to ensure that employees enjoy equal and lawful rights to labor remuneration, social insurances, employee benefits, and statutory holidays.

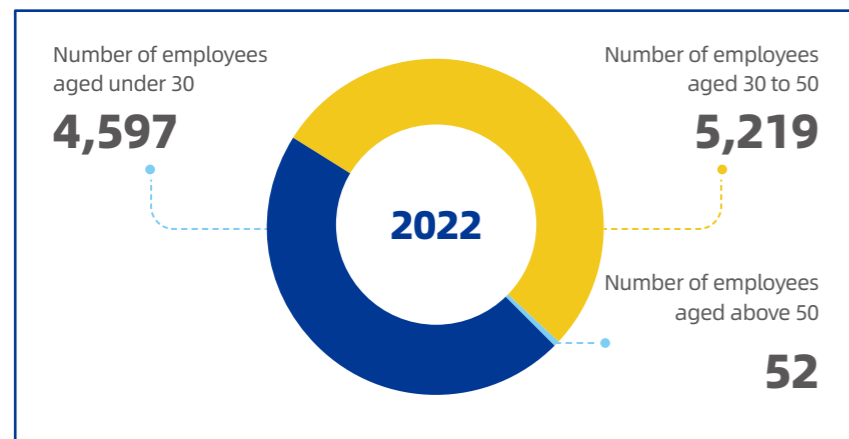
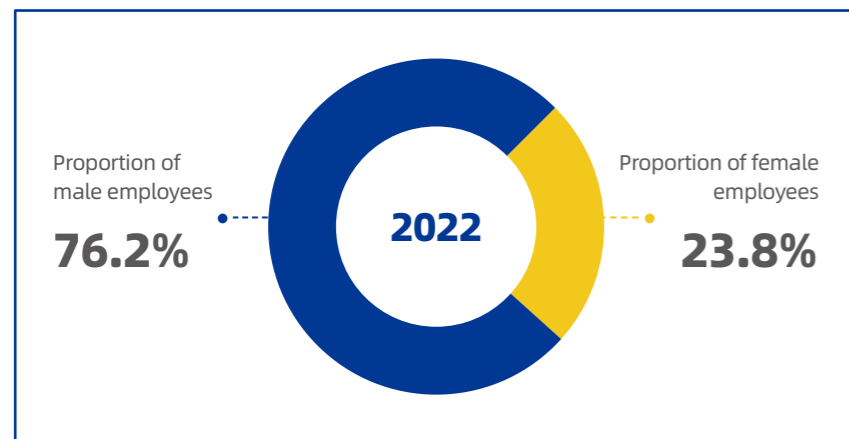
In accordance with the Qi An Xin Recruitment Management Measures, the Company mandates the implementation of an equal and fair recruitment process, and ensures equality and non-discrimination in the processes of employment, entry, promotion and resignation. These efforts aim to attract outstanding talents and provide all employees with fair and inclusive development opportunities. Moreover, Qi An Xin prohibits child labor and forced labor, which is reinforced through the mandatory checking of the identity documents of all recruited employees. The Company also cracks down on any forms of physical punishment, harassment and other acts damaging the rights and interests of employees. As specified in the Qi An Xin Employee Handbook, the Company will not hesitate to terminate the labor contract with any employee found to be in severe violation of the code of conduct.



Employment Diversity

With diversity as an important source of enterprise vitality, Qi An Xin is committed to building a diversified, equal, and respectful workplace. To this end, we constantly optimize internal rules and regulations such as the Qi An Xin Employee Handbook, strictly require partners and suppliers to abide by applicable rules and regulations, and strongly encourage them to formulate relevant rules and regulations according to their respective conditions and circumstances.

Upholding gender equality, Qi An Xin attaches great importance to the rights and interests, remuneration and welfare of female employees. To be specific, the Company supports the equal rights and employment opportunities of female and guarantees equal pay for equal work for both male and female employees under the same conditions. In 2022, females accounted for 23.8% of total employees and 21.3% of total executives in Qi An Xin.

Democratic Communication

Smooth communication channels and fair handling procedures help employees fully express their opinions and create a workplace that supports democratic communication. Qi An Xin has established an equal and democratic multi-channel communication and feedback mechanism through the internal communication software, "Lanxin", "Tengyun", dedicated email addresses, morning meetings as well as regular meetings, thus enabling effective feedback and allowing employees to express their opinions and suggestions.

In addition, Qi An Xin has set up the labor union and grants all employees the right to join the labor union and participate in collective bargaining. The labor union makes efforts to foster organizational building, stability maintenance and right protection, employee activities, and care for employees to effectively protect the rights and interests of employees. The employee assembly organized by the labor union holds regular annual staff meetings to review and vote on employee-related rules and regulations in order to ensure that the needs of employees are met.

Remuneration and Benefits

In accordance with national policies and regulations, Qi An Xin has provided employees with competitive remuneration and benefits with consideration to its operation conditions and objectives. It has also established a performance-based incentive mechanism, giving priority to employees with excellent performance and those holding key positions. To protect the rights and interests of employees as far as possible, Qi An Xin conducts market remuneration research and annual review and revision of its remuneration system. After assessment and revision, the Company fully communicates with employees to ensure that they understand the updated remuneration system, and that all questions on the remuneration policy and system are clarified timely.

In addition to salary, Qi An Xin provides employees with necessary subsidies for communication, transportation, stationing, accommodation and travel. For employees working overseas temporarily, the Company purchases additional commercial insurance, increases team building funds, and arranges home leaves, subsidies for these home leaves, and other benefits. Moreover, the Company offers additional employees benefits such as birthday, marriage and maternity benefits and also sends greetings to hospitalized employees, condolences to employees in mourning for family members who have passed away as well as gifts during festivals and holidays.

Occupational Health Management

In line with the applicable national laws and regulations of occupational disease prevention and control, Qi An Xin is committed to fostering a safe and comfortable workplace for employees. Qi An Xin prioritizes and has enforced occupational health and safety management across all business sectors. In 2022, the Company had no occupational disease incidents and arranged for all employees to receive medical examinations, free of charge. Furthermore, the Company cares for the family members of employees by offering benefits such as preferential policy of physical examination and health consultation.



Career Development and Training



Focusing on talent cultivation and development, Qi An Xin encourages employees to continue learning and upgrading their knowledge and skills for consistent self-improvement and long-term development. The Company has helped employees in different positions visualize their career development paths in hopes that all employees will play their part and develop well along their career paths.

Career Development Path

Employees are indispensable to the overall improvement of comprehensive strength and are the foundation of business capacity in an enterprise. With strong emphasis on the development of employees, Qi An Xin has designed multiple development paths for employees, and established a comprehensive official ranking system to recognize their growth and contribution.

※ Dual Career Development Channels

Qi An Xin has set up a "dual channel of career development", consisting of a "professional channel" and a "management channel". Employees may choose either of the two channels according to their own aspiration and expertise. The "dual channel" pathway allows employees to focus their own strengths for capacity building, formulating clearer career development plan.

Regarding the "professional channel", in 2022, Qi An Xin published internal documents including the *Qi An Xin Management Measures for Professional Position Promotion*, the *Notice on Establishing the Rank Management Committee*, and the *Notice on Launching 2022 Professional Position Promotion Assessment*. The Company also formulated the professional qualification standards for security, R&D, products, solution consulting, pre-sales support, and technical services, ensuring promotion equality.

Regarding the "management channel" Qi An Xin has released standards and systems such as the *Qi An Xin Manager Qualification Standard*, and the *Qi An Xin Manual for the Five-ability Model of Managers* to guide managers to grow. Besides, in accordance with the *Qi An Xin Management Measures for Manager Selection and Appointment*, Qi An Xin has improved the standards and procedures for manager selection and appointment, along with the establishment of a selection and appointment mechanism that allows outstanding managers to perform well regardless of positions, thereby ensuring the orderly and reasonable transfer of managers.

※ Mechanism of Open Selection and Competition for Posts

The Company provides multiple promotion channels for outstanding managers and professionals, with the practice of open selection and competition for posts. In 2022, the Company launched the competition for dozens of management and professional positions such as chief manager, chief engineer, managers of the General Pre-Sales Support Department, the Marketing Department and the Service Department, as well as leaders of divisions. This move has reaped excellent results. It has provided not only multiple promotion channels for employees and managers, greatly stimulating their enthusiasm, but also the reasonable transfer of talents, thus guaranteeing open and fair promotion channels.

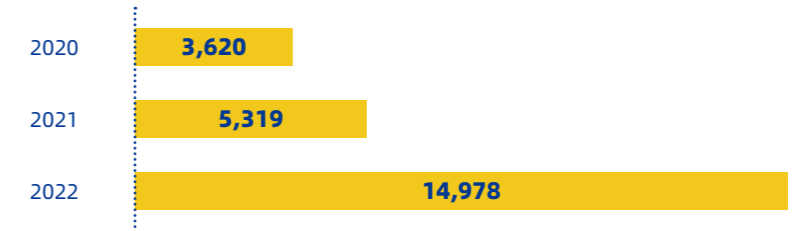

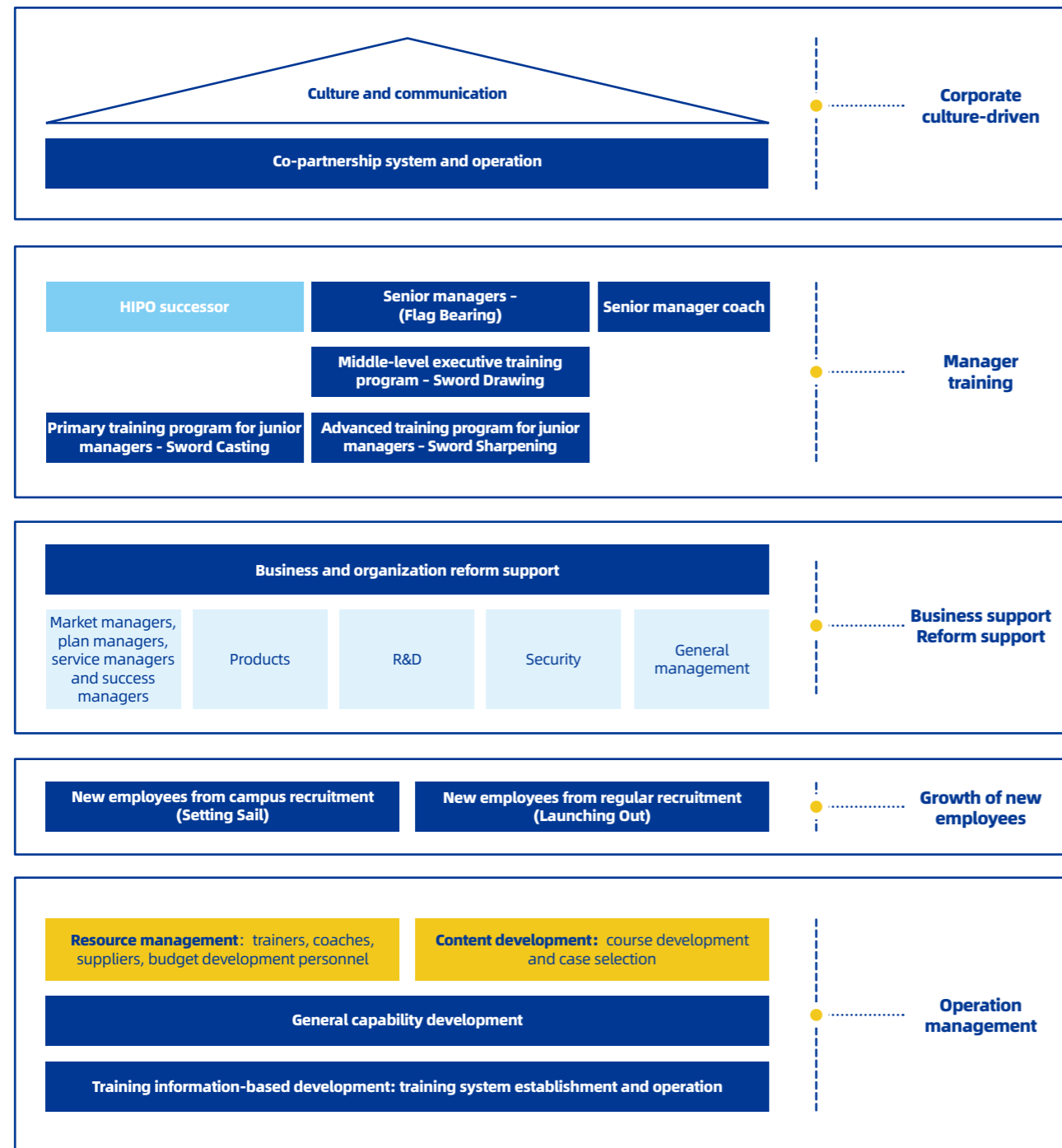
Total number of trainees covered by talent cultivation courses (人次)

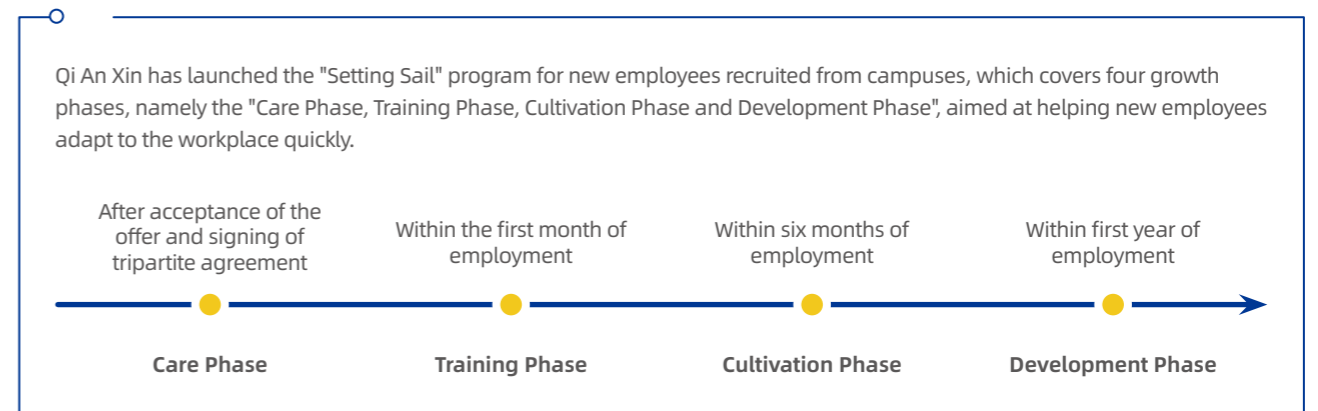

Training Program for Middle-level Managers – Sword Drawing



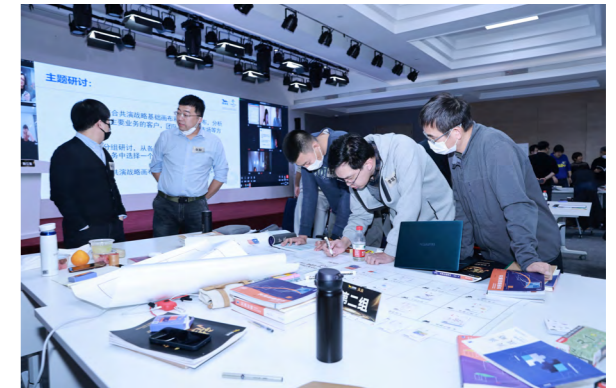

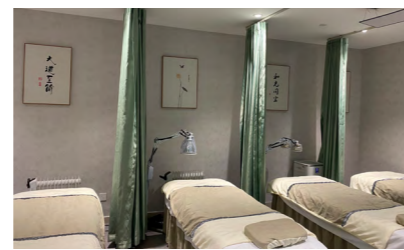

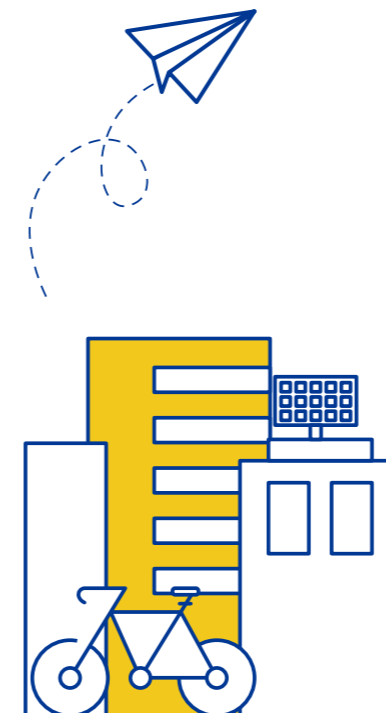

Shouldering the mission of "making the world safer and the life better, Qi An Xin Charity Foundation is committed to organizing public welfare programs for financially vulnerable groups, such as emergency relief, capability training, and environmental improvement, to reduce their risks of returning to poverty due to diseases, disasters, education, and other factors. Since its establishment in 2021, Qi An Xin Charity Foundation has set work guidelines and program principles. With the medium and low-income populations as its targets, the Foundation has established the public welfare system according to national policies and initiatives, which covers four programs, namely the "Medical Assistance Program", the "Educational Assistance Program", the "Disaster Relief Program", and the "Rural Development Program". Among them, the "Rural Development Program" focus on the improvement of rural living environment and industrial development, which will be launched in 2023.



In 2022, Qi An Xin Group donated RMB 4 million to Beijing Qi An Xin Charity Foundation for public welfare programs in education, health care, rural development, and disaster relief. Qi An Xin Charity Foundation conducted public welfare programs in 14 provinces throughout the year, with over 380,000 beneficiaries.



Contributing to Healthy China Initiative



To prevent the low-income population from slipping back into poverty due to illness, Qi An Xin Charity Foundation has launched the healthcare aid program, which focuses on issues like inadequate diagnosis and poor treatment capacity of primary hospitals, weak ability of patients in need to pay medical bills, and high treatment costs of serious diseases, as a response to the national Healthy China initiative. The "Medical Assistance Program" acts as a bridge for cooperation between major hospitals and primary hospitals to help primary medical institutions enhance their competence in the diagnosis and treatment of serious illnesses, reduce the probability of poor families to slip back into poverty due to illness, and drive Healthy China Initiative.

Medical Assistance Program of Eye Diseases - Enhancing Diagnosis and Treatment Abilities of Blindness and Low Vision for Child Patients in Tibet



In 2022, Qi An Xin Charity Foundation launched the "Medical Assistance Program of Eye Diseases - Enhancing Diagnosis and Treatment Abilities of Blindness and Low Vision for Child Patients in Tibet" cooperating with Beijing Bethune Charitable Foundation, and Peking Hospital People's University. This program covers volunteering diagnosis, knowledge popularization, doctor training, and scientific research in order to reduce the difficulty of treatment for blind and low-vision children, improve the diagnosis and treatment of ophthalmic diseases among child patients, and fill the gaps in the mechanisms of screening, diagnosis and treatment of ophthalmic diseases for children in Tibet. At present, 3 videos and 8 articles have been released as to increase awareness as part of the program, and a total of 3 online doctor training sessions have also been held.

"Beating Heart, Brighten Eyes" Charitable Foundation



To help children suffering from congenital heart and eye diseases as well as cataract patients who are impoverished due to illness, Qi Xiangdong, Chairman of Qi An Xin, Chifeng Municipal Government, and Wu Yingkai Foundation for Medical Research and Development jointly launched the "Beating Heart, Brighten Eyes" Charitable Foundation. Since 2017, this program has helped 108 children who suffering from congenital heart disease receive surgeries and supported 1,539 surgeries for cataract patients. Besides, this program screens the underprivileged population living in remote pasturing areas for potential eye and cataract diseases. Over the past years, this program has screened 5,683 primary and middle school students for eye diseases, and 34,621 residents in pasturing areas faced with financial difficulties for cataract.

Providing Support and Increasing Income of Farmers Through Consumption



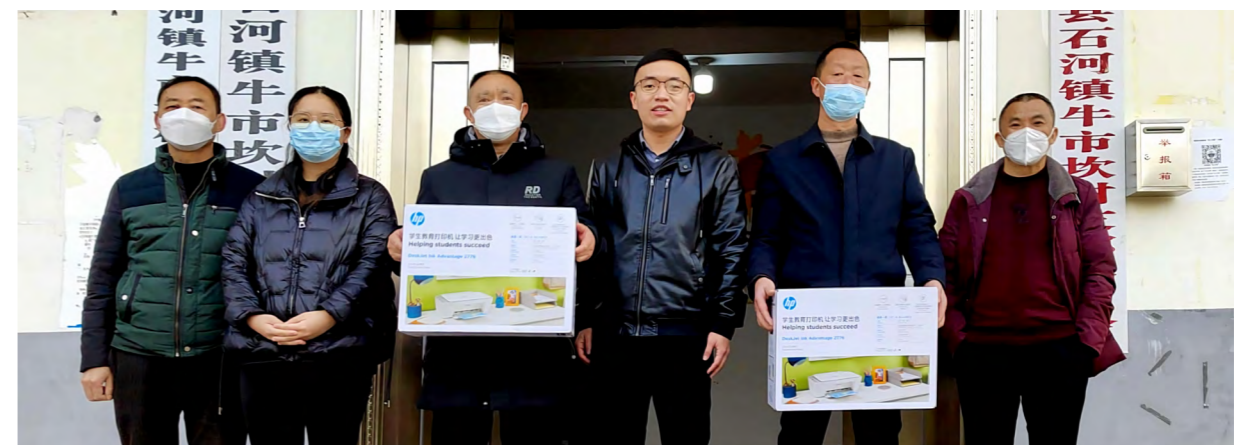

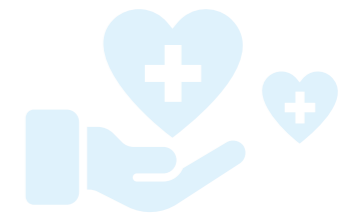

Exploring Low-carbon Operation and Proposing Innovative Solutions

In September 2020, the Chinese government clearly defined the dual goals of "carbon emission peaking" before 2030 and "carbon neutrality" before 2060. These two goals have great significance to the green and low-carbon development of China and the world.

The "dual carbon" action is an important manifestation and focus of our ecological civilization construction. Adhering to the sustainable development strategy, Qi An Xin focuses its efforts on promoting green operation, building the green and low-carbon workplace, and providing digital green solutions to drive green and low-carbon development and transformation.

Green Operations



As an emerging technology company, Qi An Xin strictly complies with the *Environmental Protection Law of the People's Republic of China* as well as other relevant laws and regulations. The Company has consistently maintained a clean record of zero violations and zero penalties for three consecutive years.



The Company has received no environmental penalties, fines or lawsuits for three consecutive years.

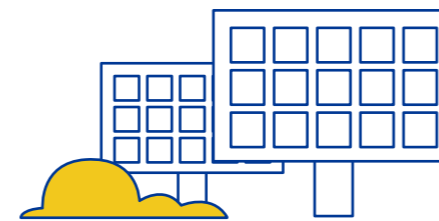


At the same time, the Company actively takes necessary measures to protect the environment and conserve resources from the aspects of energy and resource management, waste management, green information infrastructure construction, green culture cultivation, etc. This enables us to effectively reduce the impact of our operations on the ecological environment. Qi An Xin strives to be a practitioner and explorer of green and low-carbon development with the objective of contributing to the construction of a clean and beautiful world.

Energy and Resource Management

Qi An Xin continuously optimizes the usage of energy and resources. The Qi An Xin Security Center is equipped with intelligent LED lighting systems, central air conditioning systems and building intelligence systems, as well as an intelligent system that encompasses the operational, management and decision-making levels. The system has been designed to cover all energy management and planning for the entire office, which enables data collection, statistics, diagnosis, and trend analysis so as to effectively improve the efficiency of green office management.

The Qi An Xin Security Center is equipped with 7,640 environmentally-friendly and safe LED lights with long service lifespan and low energy consumption. These systems also come with multiple modes of functioning and, such as manual control and timing control according to different lighting needs in areas. The lighting system reduces light source power, line loss and ballast consumption, which cuts maintenance costs and improves energy and resource efficiency.

The central air-conditioning system is equipped with chiller units that enable natural cooling during winter, thus enhancing energy efficiency. In addition, the air-cooled heat pump units in the system come with heating functions that meet all heating demands other than the demand that is met by municipal heat sources during heating seasons. This effectively reduces the load and energy consumption of the air-conditioning systems.

The automatic control system of the building comprises 19 fresh air units, 735 coils, 40 air supply and exhaust units and 177 fresh air valves, with 1,200 endpoint set at the front end. This enables quantitative control of air conditioning, fresh air and exhaust air, thus creating a comfortable and favorable environment for the office area in accordance with the changes in seasons and air conditions. At the same time, the automatic control system can be continuously optimized based on historical data to cope with the average equipment load work, improve equipment operation efficiency, extend equipment lifespan and effectively control the occurrence of malfunction. The automatic control system of the building lowers management costs while achieving the goal of energy conservation and consumption reduction.



Water Resource Management

Qi An Xin always advocates and practices the concept of water conservation. To this end, the Company has installed water-saving sanitary products, such as water-saving basins and foot valves in pantries and washrooms. In addition, the 4,000-square-meter green area on the roof of the Qi An Xin Security Center is fitted with a water-saving micro-irrigation system. With a series of water conservation measures, Qi An Xin pursues maximum water efficiency.

Water-saving Micro-irrigation System



In order to ensure the scientific use of water resources, the Qi An Xin Security Center Sky Garden has adopted a water-saving micro-irrigation system, which achieves the goal of water and energy conservation by making full use of the noise and gaseous pollutant adsorption effect of green plants while rationalizing irrigation and reducing water waste. At the same time, this also creates a comfortable workplace environment.



Waste Management

In terms of waste management, Qi An Xin has been actively carrying out waste separation and sorting at all operating sites in Beijing since 2020, in accordance with the *Beijing Municipal Regulations on Domestic Waste Management*. The Company has purchased four-color waste separation bins, equipped with waste classification signs and posters. Additional full-time sorters have also been arranged to carry out secondary sorting so as to continuously strengthen employees' waste sorting awareness while ensuring that the waste sorting standards are met. On this basis, the company also signed a waste disposal agreement with a professional waste disposal company to ensure that domestic waste is legally disposed of in accordance with the relevant laws and regulations.

In addition, the cafeteria of the Qi An Xin Safety Center has been equipped with electrostatic grease purifiers in the air ducts to ensure that the fumes emissions meet the requirements of Beijing municipal standard DB11/1488-2008.

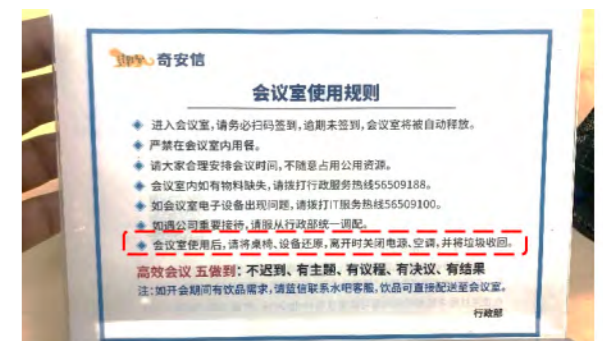

※ Green Culture

Qi An Xin makes constant efforts to promote green culture development, and encourage employees to perform green conducts in the workplace. Specifically, the Company disseminates the energy conservation and consumption reduction policy to all employees, reminding them to switch off lights and other office devices when they leave the workplace and conference rooms. At the same time, the Company assigns property management personnel and security personnel to inspect the energy consumption and usage of office facilities. Besides, the Company has installed 21 charging piles for electric vehicles in the Qi An Xin Security Center, which encourages employees to travel in an environmentally friendly manner.



Green Information Infrastructure

As the digital informatization develops rapidly, green information infrastructure has become the general trend. To achieve sustainable development, Qi An Xin has taken full measures to promote energy conservation and consumption reduction such as improving the cabinet layout, optimizing the water circulation system, enhancing equipment management efficiency, and developing virtualization technology, in an attempt to respond to the national call on green information infrastructure construction.

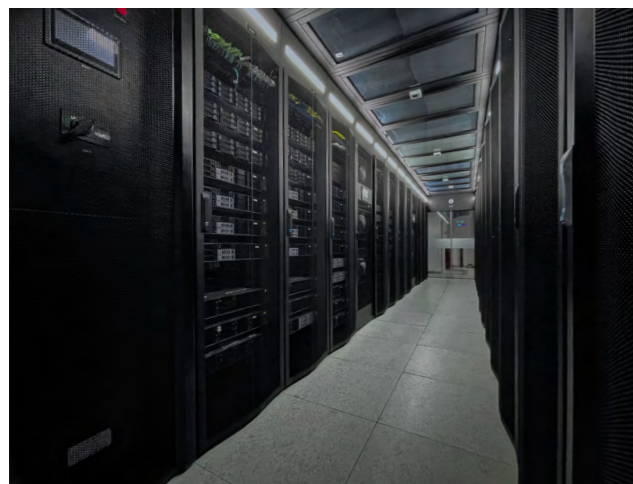

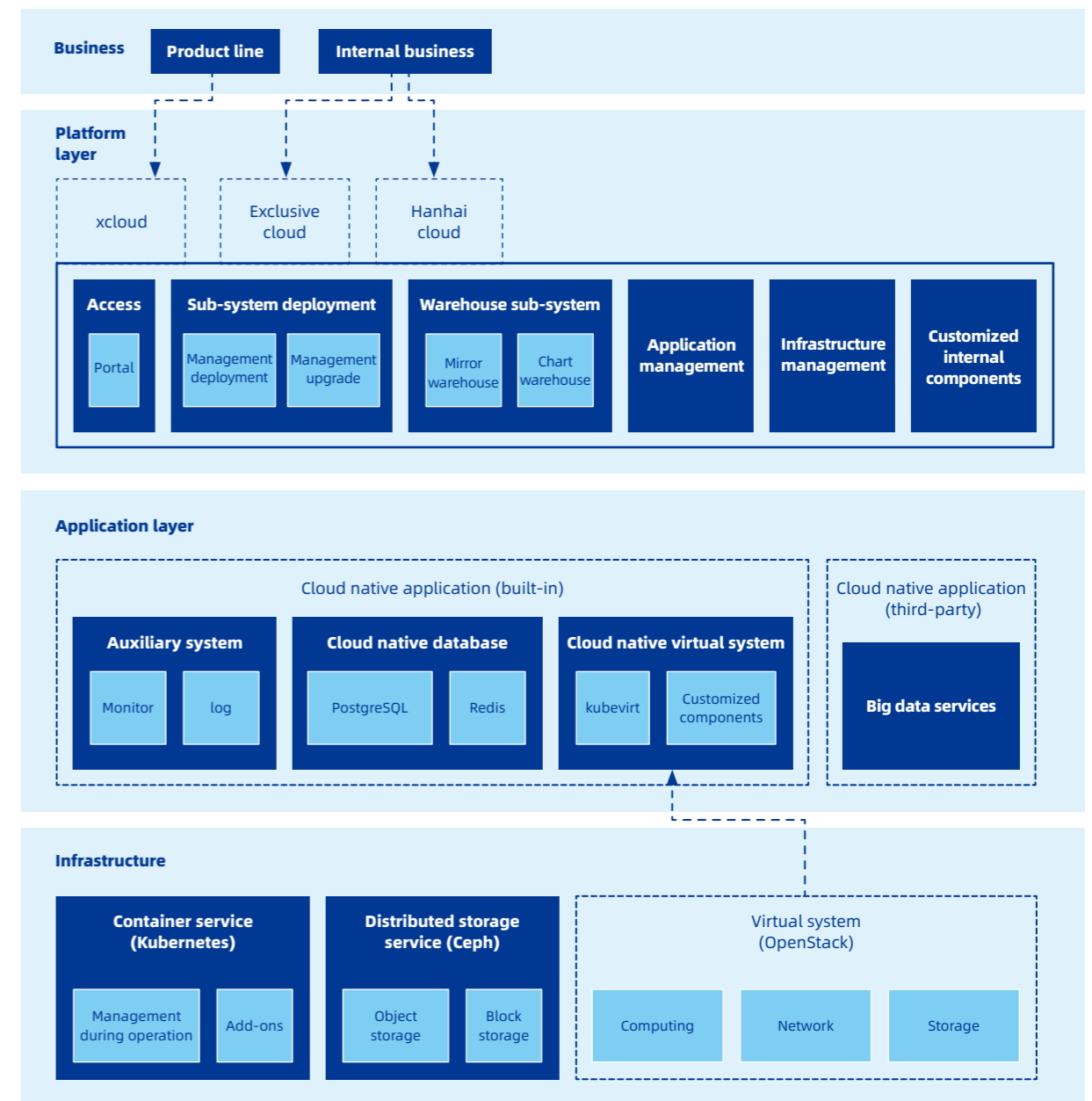
Develop a virtual cloud computing platform independently to pool server resources, which improves system stability, lowers maintenance costs, and reduces energy consumption.



Virtualization Technology: Helping Energy Conservation and Emission Reduction



To mitigate the issue of high electricity consumption, excessive footprint, low resource utilization rate, and high operation and maintenance costs of equipment, Qi An Xin has developed private cloud computing technology. The technology is mainly used for the aggregation of office network in the building, internal R&D and test. According to computing load, the cloud computing technology works to allow the automatic allocation of resources and turn the idle server to the low-power operation state, thus facilitating green computing, and reducing carbon emissions.

On the one hand, these platforms meet the digital management needs of customers, and on the other hand, they provide green solutions to diversified business management.

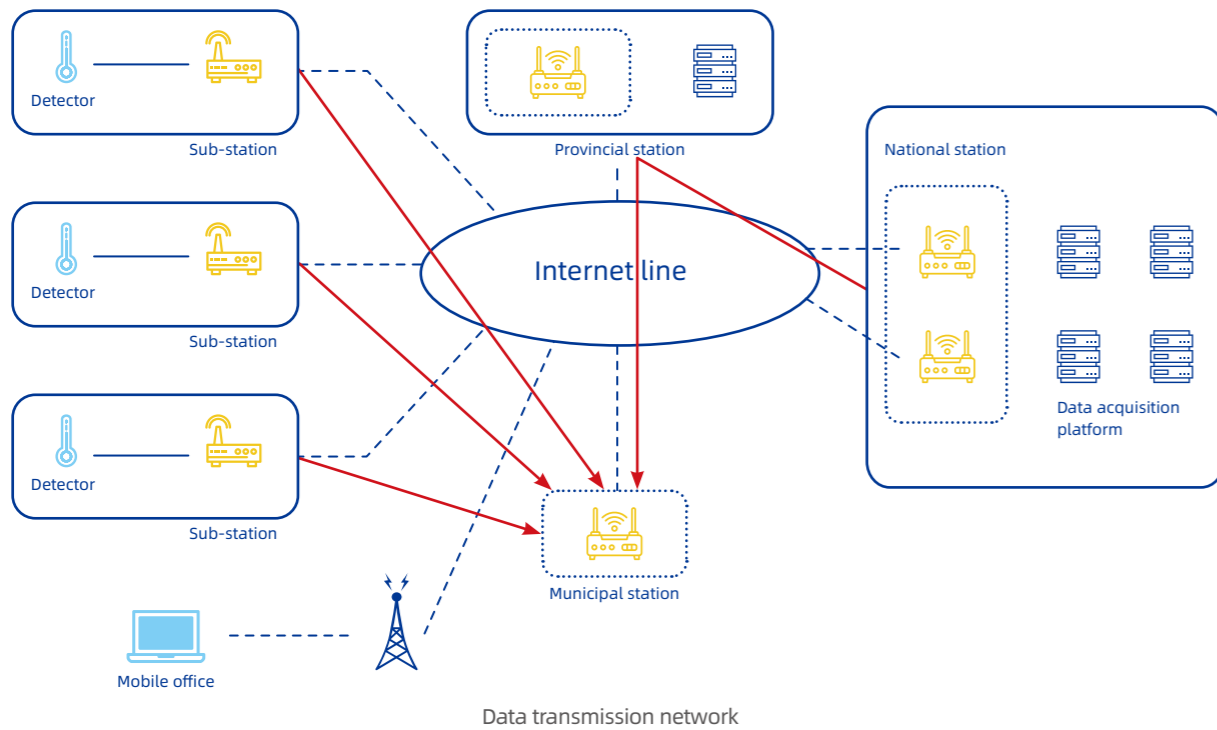

Qi An Xin has improved resource utilization efficiency and accuracy of monitoring and management by building an intelligent data platform and working out new green and energy-saving solutions. This promotes the synergy of digitalization and greening.



Air Quality Monitoring Safety System for Our National-level Client in the Ecological Environment Industry



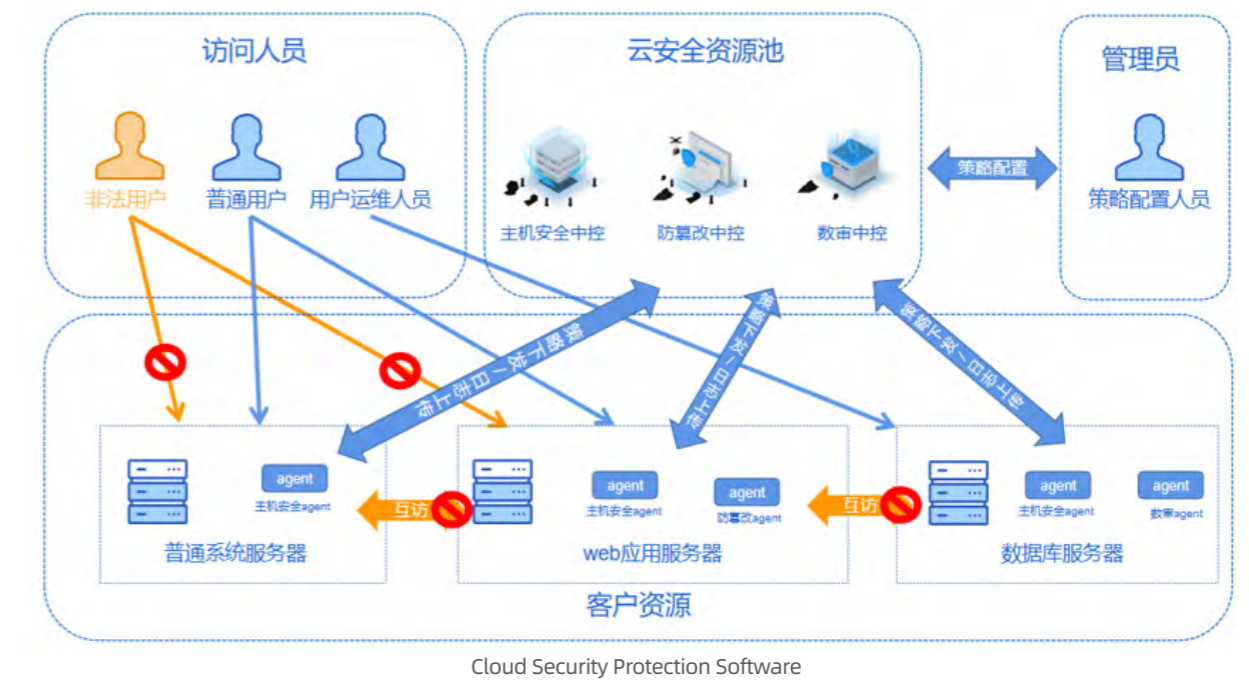
In June 2022, Qi An Xin provided data transmission network services for a national-level customer in the ecological environment industry, serving as an active response to the green development strategy. Under the prerequisite of meeting the transmission tunnel encryption requirement, the system is furnished with vulnerability protection, anti-DDoS protection, and deep threat identification. The project has also adopted a "green and intelligent" solution that replaces traditional VPN with SDWAN. Through the 4G/5G network, the system not only improves security, adds intelligent path selection function, and ensures smooth ambient air monitoring, but also reduces the electricity consumption of equipment, and reduces carbon dioxide emissions.



Cloud Security Protection Project for a Government Body



In June 2022, Qi An Xin built a cloud security protection project together with a government body. On the one hand, the project has reduced hardware resource waste by using existing cloud resources. On the other hand, the project has effectively blocked illegal east-west traffic and reduced possible malware and attacks in the business network through the cloud security protection software. Hence, it has effectively improved security protection level, guaranteed the business stability of the customer, and enhanced the customer's ability to respond to major events.
